

April 2024 NCEL 200 Weekend Ticket Giveaway

OFFICIAL RULES:

1. **PROMOTION PERIOD:** The North Carolina Education Lottery (“Sponsor”) NCEL 200 Weekend Ticket Giveaway (“Promotion”) begins on Wednesday, April 17th, 2024 at 12:00 a.m. Eastern Time (“ET”) and will end on Monday, April 22nd, 2024 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish two (2) “Promotion Posts” on its social platforms – one to its official Facebook page (<https://facebook.com/nclottery>) and one to its official Instagram page (<https://instagram.com/nclottery>). The Promotion will include two (2) drawings at the conclusion of the entry period, each for five (5) winners, for a total of ten (10) winners for this Promotion. Each winner will receive two (2) tickets to the Coca-Cola 600 weekend event (“Prize”) that takes place on May 24th-26th, 2024 at Charlotte Motor Speedway in Concord, North Carolina. The tickets will allow winners to attend all events throughout the weekend, including the *North Carolina Education Lottery 200* on Friday, May 24th, the *BetMGM 300* on Saturday, May 25th, and the *Coca-Cola 600* on Sunday, May 26th. Estimated Retail Value (“ERV”) of each Prize is \$378.00. ERV of all Prizes in this Promotion is \$3,780.00.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by

law. 3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. Any social persona may enter a comment in each Promotion Entry Period, but may only win one prize. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users will enter with a comment on the official Facebook promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the specified time period on the official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook as determined by the Sponsor and adhering to the NCEL social media policy.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

INSTAGRAM: Users will enter with a comment on the official Instagram promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the specified time period on the official Instagram Promotion Post. Responses made on other Instagram posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Instagram as determined by the Sponsor and adhering to the NCEL social media policy.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in any drawing depend on the number of entries received for the drawing. Entries will be collected via comments on the Promotion's Facebook post for a combined pool of entrants for the first drawing, and via comments on the Promotion's Instagram post for a combined pool of entrants for the second drawing. Five (5) entrants will be randomly selected in each drawing to win a Prize, for a total of ten (10) Promotion winners. Total Estimated Retail Value ("ERV") of each Prize is \$378.00. Total ERV of all prizes awarded in this promotion is \$3,780.00. Prizes are not transferable, assignable, or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value.

After a drawing is conducted and verified, eligible winners will be announced on the official Facebook and Instagram Promotion Posts and notified by comment response and direct message via Facebook or Instagram, respectively. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name, North Carolina mailing address, birthdate, phone number and email address to the Sponsor's notification via Facebook, they may be disqualified and the prize will be awarded to an alternate. Winner must accept the entire Prize package or decline the entire Prize package; no winner shall be entitled to receive only part of the Prize. Regardless of whether a winner uses all of the Prize package, the entire value of the Prize package will be reported for tax purposes, if applicable.

Prizes will be emailed to the email addresses provided by the winners via an electronic ticket transfer.

All winners shall be required to have, or create, a Ticketmaster account to receive their tickets and shall be follow all Ticketmaster terms and conditions. Additionally, all winners shall follow all Charlotte Motor Speedway rules and policies.
