

September 2025 Mumfest VIP Ticket Social Media Giveaway

OFFICIAL RULES:

1. **PROMOTION PERIOD:** The North Carolina Education Lottery (“Sponsor”) September 2025 Mumfest VIP Ticket Social Media Giveaway (“Promotion”) begins on Tuesday, September 16th, 2025 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, September 21st, 2025 at 11:59 p.m. ET (“Promotion Period”). During the Promotion Period, the Sponsor will publish one (1) “Promotion Post” on its official Facebook page (<https://facebook.com/nclottery>). At the conclusion of the Promotion Period, the NCEL will conduct one (1) drawing for a total of one (1) winner for this Promotion. The winner will receive two (2) meet-and-greet passes for one (1) Mumfest concert on Saturday, September 28th, 2025, two (2) passes to the VIP Music Tent, and two (2) NC Education Lottery swag bags, which will include a NC Education Lottery-branded t-shirt, cooler bag, hat, and a scratch-off ticket (“Prize”). Estimated Retail Value (“ERV”) the Prize for this Promotion is \$220.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures, and Facebook and Instagram rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor,

3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for the specified Promotion Entry Period during the Promotion. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users will enter with a comment on the official Facebook Promotion Post. A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, courier, drop-off, etc. will be disqualified.

4. WINNERS & PRIZE: Odds of winning in each drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Facebook post at the end of the Entry Deadline period for the drawing. One (1) winner will be randomly selected to receive a Prize. Total ERV of the Prize for this Promotion is \$200.00.

Winners are subject to minimum Federal and State taxes and other State withholdings, as required by law. The NCEL will issue an IRS Form W-2G to Prize winners for Prize wins above \$599.

After a drawing is conducted and verified, eligible winners will be notified by comment reply or direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within twenty-four (24) hours of notification, they will forfeit the Prize and the Prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name,

The Prize will be picked up on-site at the Mumfest 2025 event, and Prize pickup instructions will be emailed to the winner.

The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Promotion; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Promotion; or to be otherwise acting in an unsportsmanlike manner.
