November 2025 Sky's The Limit Social Media Promotion

OFFICIAL RULES:

1. ENTRY PERIOD: The North Carolina Education Lottery ("Sponsor") November 2025 "Sky's The Limit" Social Media Promotion ("Promotion") begins on Tuesday, November 4th, 2025 at 12:00 a.m. Eastern Time ("ET") and ends on Sunday, November 30th, 2025 at 11:59 p.m. ET ("Promotion Period"). During the Promotion Period, players may visit the "Sky's The Limit" promotion website (https://thegiftofwhatif.com) where they can participate in the web game and complete the entry form. The Promotion includes one (1) drawing following the conclusion of the Promotion Period, which shall select a total of ten (10) winners, who will each receive assortment of sixty (60) scratch-off tickets, ten (10) of each of Games #016-021 ("Prize"). Estimated Retail Value ("ERV") of each Prize is \$430. ERV of all Prizes in this Promotion is \$4,300.

3. HOW TO ENTER: There is a limit of one (1) eligible entry per person for the specified entry period during the Promotion. All entries must be submitted via the promotion website during the Drawing Entry Period to be eligible for the drawing.

Winners will be randomly selected from the following method of entry:

PROMOTION WEBSITE: Users may enter by completing the activity on the promotion website (https://thegiftofwhatif.com). After completing the game, players may enter the Promotion by filling out the entry form fields with their name, email address, and phone number, and confirming they meet the eligibility requirements.
