Fast Play Lunch Break

Available at all Lottery retailers, players who buy a \$2 Fast Play Bingo Bucks ticket will receive a free \$2 Fast Play Bingo Bucks ticket free instantly. This promotion will run 12:00 p.m. through 3:00 p.m. on Thursday December 30, 2021. This date/time is subject to change at the sole discretion of the NCEL.

Any North Carolina Education Lottery ticket purchased that qualifies for a promotion cannot be canceled during the promotion period.
