A \$.50 base Pick 3 or Pick 4 ticket with Fireball equals \$1 and is eligible for this promotion. If the \$5 instant cash is won the printed draw game ticket will have a Special Offer message and barcode. Detach and give the Special Offer voucher to the lottery retail clerk and you will be provided \$5 cash. The Special Offer vouchers are not redeemable at Lottery Vending Machines.

During this promotion, a Pick 3 or Pick 4 ticket that gets an Instant Cash Special message and barcode to receive \$5 in Instant Cash cannot be canceled for the drawing.
