## **April 7's Photo Submission Gift Card Promotion**

## **OFFICIAL RULES:**

Selected entrants for prizes must be able to prove residency, age and provide a mailing address. By submitting an entry, Entrant agrees to comply with NCEL social media policy. Entrants DO NOT have to be a Player's Club or Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations.
