The BIGGER SPIN PRIZE AND PROMOTIONAL RULES

BIGGER SPIN PRIZE AND LIVE SPIN

- The Bigger Spin Live Events are only open to "The Bigger Spin" scratch-off game (Scratch Off Game #779) winners whose winning tickets indicate they have won a "Bigger Spin" prize (each a "Prizewinner"). Each Prizewinner will have an opportunity to spin The Bigger Spin Wheel (the "Wheel") to win a cash prize ranging from \$400,000 up to \$2,000,000 ("The Bigger Spin Live Event(s)").
- 2. Bigger Spin Live Events are pre-scheduled. Once a ticket with a "Bigger Spin" prize is validated and claimed for payment at a Lottery office the date of the Bigger Spin Live Event will be confirmed and instructions provided to Prizewinners.
- 3. Bigger Spin Live Events will be held on Wednesdays based on the show schedule established by the Lottery. All Prizewinners must be scheduled by the end of business day on the Thursday before the upcoming Wednesday's Bigger Spin Live Event.
- 4. Bigger Spin Live Events are planned to be held at WRAL Television studios located at 2619 Western Boulevard in Raleigh. The North Carolina Education Lottery ("NCEL" or "Lottery") reserves the right to hold the Bigger Spin Live Events at a location other than WRAL, as necessary.
- 5. Each Bigger Spin Prizewinner will have one practice spin on the Wheel prior to the Bigger Spin live event. When the Bigger Spin Live Event commences, a Bigger Spin Prizewinner gets three (3) attempts to complete a valid spin. A valid spin consists of at least three (3) full three-hundred sixty degree (360°) rotations of Wheel in a downward direction, as determined by the North Carolina Education Lottery. After the player has completed his/her first valid Spin, he/she will not be provided any more opportunities to Spin. If the Bigger Spin Prizewinner cannot complete a valid Spin after three attempts, the Prizewinner will receive the minimum prize of \$400,000.
- 6. The start position of the Wheel will be at the \$2,000,000 prize spot on the Wheel.
- 7. The Prizewinner may designate a proxy, or have one chosen by the Lottery to spin the wheel on his or her behalf. The proxy must be 18 years of age or older to be eligible to participate in the Bigger Spin Live Event. Any prize resulting from the proxy spin shall be attributed to the Prizewinner and the Prizewinner shall have no further opportunities to spin the Wheel.
- 8. In the event that the prize Wheel stops in between two prize amounts, the higher of the two prizes will be awarded.
- 9. A representative from the Lottery's Security Department plus an independent third-party auditor will monitor each Wheel spin. Their decision pertaining to spin rotations and prize award-landing positions shall be deemed final.
- 10. The Lottery shall offer each Bigger Spin Prizewinner a one-night stay in a double occupancy room for the Prizewinner and one (1) guest the night before the official Bigger Spin Live Event

("Accommodations"). For Prizewinners who accept the offer of overnight stay accommodations, the North Carolina Education Lottery will handle booking and payment of the one-night stay.

- 11. The Lottery shall provide each Prizewinner with an additional \$100 stipend for miscellaneous expenses such as food, etc. that will be included in their final prize payment ("Stipend"). Prizewinners are responsible for all expenses beyond the accommodations.
- 12. By participating in the Bigger Spin Live Event, Prizewinners understand, acknowledge, and agree that NCEL, its retailers and advertising agencies, and the news media may use each Prizewinner's name, likeness, and statements for reproduction as it relates to winner awareness for purposes of advertising, promotion, display, or exhibition. Prizewinners further agree to participate in interviews with NCEL public relations personnel.
- 13. The Bigger Spin Live Events may be streamed on Social Media sites and/or taped for future broadcast use. In order to participate in the Bigger Spin Live Event, each Prizewinner and, if applicable, each Proxy must complete and sign the Appearance Release form provided by the NCEL and, if applicable, any similar form required by WRAL-TV. Failure or refusal to sign the Appearance Release shall result in the applicable Prizewinner's disqualification from the Bigger Spin Live Event and the Prizewinner will only receive the Default Prize described in Prize Payment Section 2 below. If WRAL-TV and the NCEL allow Prizewinners to bring a guest to the Bigger Spin Live Event, each guest must also complete the Appearance Release form to be admitted to the event.
- 14. Should the Lottery determine that the Wheel mechanism has malfunctioned or is likely to malfunction due to a technical/mechanical failure, the Lottery may either declare any Spin void and require the player or Proxy to participate in a new Spin; or postpone the Wheel Spin until such time as it determines that the Wheel has been restored to proper functioning order. Any decision made pursuant to this Rule shall be final and binding and without any right of appeal.
- 15. Prizewinners and, if applicable, their Proxies agree to comply with facility, location, and safety rules of the NCEL and WRAL-TV including, without limitation, COVID-19 safety protocols. If, as a results of such rules and/or protocols, a Prizewinner is determined to be unable to participate in the Bigger Spin Live Event, the Prizewinner shall have the option of 1) allowing the NCEL to designate a proxy or 2) if, and only if, a future Bigger Spin Live Event date is available, rescheduling their spin to a future date to be mutually agreed upon by the Prizewinner and NCEL. Notwithstanding the foregoing or anything else to the contrary contained herein and even if Prizewinner makes more than one (1) trip to Raleigh to participate in the Bigger Spin Live Event, the NCEL will only provide each Prizewinner with one (1) package of Accommodations and Stipend (as described in Sections 10 and 11, respectively).

PRIZE PAYMENT

1. Upon presentment of The Bigger Spin ticket that has a "Bigger Spin" prize, the Prizewinners of the Bigger Spin Live Events must complete a Winner Claim Form at any Lottery Claim Center to claim an initial payment of \$50,000 (minus applicable State and Federal taxes and other state withholdings). The \$50,000 initial payment is part of the total prize amount that the winner will eventually receive and will be subtracted from the final prize payment to the winner following the completion of the Bigger Spin Live Event. Prizes associated with The Bigger Spin Live Event (including the initial \$50,000 prize amount) are subject to minimum Federal and State taxes and other State withholdings, as required by law. The NCEL will issue IRS Form W2-G to the Bigger Spin Live Event Prizewinners. (For example purposes only, if the Prizewinner's spin lands on the \$500,000 prize on the Wheel, the Prizewinner will receive \$450,000, less taxes and withholdings as the Prizewinner has already received the initial \$50,000 payment).

- 2. Default Prize if a player is unable or unwilling to attend the Bigger Spin Live Event and fails to designate a Proxy and/or fails or refuses to sign the Appearance Release Form or other required forms (a "Default"), the Prizewinner will receive the Default Prize of \$400,000 (which will include the initial prize claim of \$50,000, minus applicable State and Federal taxes and other state withholdings) ("Default Prize"). A Default results in the forfeiture of the potential to win any prize other than Default Prize.
- 3. In the event a Prizewinner arrives to WRAL later than one hour of the scheduled call time, the lottery can elect to postpone The Bigger Spin Live Event to the next scheduled date on the event calendar. Should the Prizewinner not arrive within the one-hour time window to the second date they will automatically be considered to have Defaulted and receive only the Default Prize.
- 4. GROUP PLAY If a "The Bigger Spin" Instant ticket was purchased by or claimed by more than one individual (a "Group"), the members of the Group shall either:
 - a. Select a single representative to participate in the Live Spin (a "Designee"). Once selected, the Designee may not be changed; or
 - b. Elect to receive the Default Prize of \$400,000.
