

Bank of America Roval 400 Ticket Giveaway Promotion

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) Bank of America Roval 400 Ticket Giveaway Promotion (“Promotion”) begins on Monday, September 9, 2019 at 1:00 p.m. Eastern Time (“ET”) and will end on Sunday, September 15, 2019 at 11:59 p.m. ET. The Promotion will include one (1) drawing on Facebook and one (1) drawing on Instagram to be held at the conclusion of each entry period for a total of twenty-five (25) winners who will each receive two (2) tickets to the Drive for the Cure 200 on Saturday, September 28, 2019 and two (2) tickets to the Bank of America Roval 400 NASCAR race on Sunday, September 29, 2019 (“Prize”).

The comments on the promotional post will be exported at the end of the entry period. The actual drawing date is subject to change at the sole discretion of the Sponsor.

2. **ELIGIBILITY:** Drawings are opened to all North Carolina residents who are at least eighteen (18) years old or older. Selected entrants for prizes must be able to prove residency, age and provide a mailing address. By submitting an entry, Entrant agrees to comply with the [NCEL social media policy](#). Entrants DO NOT have to be a Player’s Club or Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, Wunderman Thompson, Spurrier Group and MDI Entertainment, LLC are prohibited from participating in this Promotion.
3. **HOW TO ENTER:** There is a limit of one eligible comment entry per social persona for the specified entry period during the Promotion. All entries must be submitted within the Drawing Entry Period for that drawing.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users enter by commenting on the promotion post with a reply that states who they would take with them to the race. A valid entry shall be defined as the first response made by a user during the specified promotion time period on the official Facebook post. Responses made on other Facebook posts will not be eligible.

INSTAGRAM: Users enter by commenting on the promotion post with a reply that states who they would take with them to the race. A valid entry shall be defined as the first response made by a user during the specified promotion time period on the official Instagram post. Responses made on other Instagram posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook or Instagram as determined by the Sponsor and adhering to the NCEL social media policy.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. **WINNERS & PRIZE:** Odds of winning in this drawing depend on the number of entries received for that drawing. Entries will be collected via qualified comments on the Promotion's Facebook or Instagram post at the end of each Entry Deadline period for each drawing. A total of twenty-five (25) entrants will be randomly selected to win a Prize. Twenty (20) entrants will be selected from the Facebook entries. Five (5) entrants will be selected from the Instagram entries. Total Estimated Retail Value ("ERV") of the Prize is \$398.04. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may substitute a prize of equal or better quality. After a drawing is conducted and verified, eligible winners will be announced in a Facebook or Instagram post (as applicable to that winner) and notified by direct message via Facebook or Instagram (as applicable to that winner). If selected entrants do not respond to the notification directing them to contact the Sponsor within twenty-four (24) hours of notification, they will forfeit the prize. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name, address, birthdate, phone number and email address to the Sponsor's notification via Facebook, they may be disqualified and the prize will be awarded to an alternate. The Prize will be emailed to the email address provided by the winning entrant. Only one prize may be won by a person during the Drawing.

The Sponsor reserves the right to cancel or modify the Promotion if it becomes technically or otherwise corrupted. The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Promotion; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Promotion; or to be otherwise acting in an unsportsmanlike manner. The Promotion is not sponsored, endorsed, administered by, or associated with Facebook.
