"Carolina Keno Free Fast Play Ticket" **Promotion** Terms

Purpose

The North Carolina Education Lottery ("NCEL") is conducting a promotion to provide purchasers of NCEL Carolina Keno tickets the chance to receive a free \$2 Fast Play ticket at all North Carolina Education Lottery retailer locations during defined times in November 2022.

During the promotion period, the purchase of any single Carolina Keno draw game ticket costing \$5 or more qualifies to receive one free \$2 Fast Play ticket.

Promotion Period

This promotion will run 5:00am Thursday November 10 through 2:00 am Thursday December 1, 2022 (end of system day November 30, 2022). These dates are subject to change at the sole discretion of the NCEL.

Participating NCEL Draw Games

The only eligible NCEL Draw Game that will automatically qualify the player for a free \$2 Fast Play ticket is Carolina Keno.

Eligible Purchase Requirements

A qualifying ticket is defined as a purchased NCEL Carolina Keno draw game ticket costing \$5 or more. The total dollar value may be comprised of base game play plus any additional features (multiplier, multidraw).

The free \$2 Fast Play ticket will contain the ticket message as shown below.
