

# ULTIMATE DASH® Challenge Second Chance Drawing Promotion Rules and Regulations

## Drawing Dates

Two (2) second chance drawings will be conducted by the North Carolina Education Lottery ("NCEL" or "Sponsor") for the ULTIMATE DASH® instant scratch-off ticket (Instant Game #929) Second Chance Drawing Promotion ("Promotion") during the selling period of the game or such time period as determined by the NCEL. The tentative drawing schedule for the ULTIMATE DASH® Challenge Second Chance Drawing Promotion is as follows:

Any changes will be announced by the NCEL at the earliest practical date via the NCEL's official website ([www.nclottery.com](http://www.nclottery.com)) and the information may also be obtained by calling the Customer Support Center at (866) 934-0289.

## Winners

Twelve (12) ULTIMATE DASH® Challenge Second Chance Winners will be selected in each of two (2) separate second chance drawings during the promotion period. The NCEL reserves the right, in its sole discretion, to substitute any prize with an alternate prize of equal or greater value.

## ULTIMATE DASH® Trip Prize Package

The ULTIMATE DASH® Trip Prize is a three-day, two-night trip for the North Carolina Lottery prizewinners (each, a "Prizewinner") and one (1) guest to Charlotte, North Carolina in June 2024 or a date to be determined (the "Trip Package") and includes:

- Travel allowance for each Prizewinner of five hundred dollars (\$500) to be provided in the form of a check two (2) weeks prior to the scheduled trip departure date;
- Accommodations of one (1) hotel room for two (2) nights (double occupancy, room, and room tax only) at a three-diamond rated hotel or better;
- Prizewinner and guest will be honored with a welcome reception/dinner the evening of their arrival to Charlotte, North Carolina; and

- Admission to the ULTIMATE DASH® Challenge Event (the “**Dash Event**”) venue for the Prizewinner and guest. The Prizewinner and their one (1) guest shall have the opportunity to participate in a ninety second (:90) DASH through the Dash Event warehouse to place into their shopping cart as much merchandise as they can (the merchandise successfully placed into the shopping cart within ninety seconds (:90) is sometimes referred to as “**Merchandise Prizes**” or “**Merchandise Prizes Won**”). At the conclusion of all of the DASHES, each Prizewinner shall have a chance to win a cash prize of up two million dollars (\$2,000,000) in the Double Jackpot Spin Bonus Game (the “**Bonus Game**”).
- Prizewinner is solely responsible for the actions of the guest who accompanies the Prizewinner.
- If Prizewinner has outstanding state-owed debt or child support obligations, such amounts will be deducted from the five hundred dollar (\$500) travel allowance and five hundred dollar (\$500) guaranteed minimum Bonus Game Cash Prize. If the outstanding amounts exceed one thousand dollars (\$1,000), Prizewinner must settle such amounts that exceed one thousand dollars (\$1,000) prior to being awarded any prizes. If Prizewinner does not settle state-owed debt and/or child support, within ten (10) days of notification by LOTTERY, Prizewinner will be deemed ineligible and an alternate Prizewinner will be selected.

Total estimated retail value of each Ultimate Dash Trip Package and Dash Event Merchandise prizes is \$34,265.74. The actual retail value of the Merchandise prize will be calculated once the Dash Event run is complete. The value does not include any cash prizes won during the Bonus Game, which will vary from Prizewinner to Prizewinner between \$500 and \$2,000,000 according to the rules below. Additional conditions apply. Except as provided in these Rules, the Trip Package is non-transferable and non-assignable.

## **ULTIMATE DASH® Event Prizes**

The Dash Event is managed by Hinda, Inc. (“**HINDA**”) and shall be conducted according to event and security procedures generated by Scientific Games, LLC (“**SG**”) and its third-party underwriter, SCA Promotions, Inc. (“**SCA**”), a company specializing in promotional prize coverage and risk management. Final event details explaining how the event will be conducted will be mailed no later than two (2) weeks prior to the date of the event or once the prize is claimed, whichever is later.

Each Prizewinner (or an assigned proxy) (each, a “**Contestant**”) and guest shall have one (1) chance to participate as a Contestant in the Dash Event Course at a time. Contestant, or guest, may elect to have a proxy (a “**Proxy**”) complete the DASH on their behalf. A Proxy must be requested prior to the first Contestant’s Dash Event at the applicable Dash Event. Proxies shall be provided by HINDA, SG, or SCA without warranty as to their suitability to act as proxy. Contestant and guest shall have no right to select a proxy that is not provided by HINDA, SG, or SCA. Contestants

and guests that request a proxy hereby disclaim and release Proxy, HINDA, SG, SCA, and NCEL from any and all liability related to a proxy's performance. Contestants and guests must be eighteen (18) years or older to participate in a DASH.

There will be two (2) Dash Events and two (2) Bonus Games.

### DASH EVENT

At each Dash Event, each Prizewinner and their one (1) guest will have ninety seconds (:90) to collect as much merchandise as possible as described below (each a “**DASH**” or plural the “**DASHES**”). After each DASH is complete, each Prizewinner shall have the chance to win a cash prize of five hundred dollars (\$500) up to two million dollars (\$2,000,000) in the Bonus Game.

- Each team will be supplied with a minimum of one (1) empty cart (40” long, 27” wide, and 30” high).
- The team will consist of two (2) people, made up of the Prizewinner and Prizewinner's guest. The Prizewinner's guest will assist them in the Dash Event Course.
- One team member will be the dedicated “pusher,” and the other team member will be the dedicated “picker.” Please note, the “pusher” can rearrange items in the cart, but may NOT pull items from the shelves. Any item pulled, picked or otherwise removed from the shelves by the “pusher” shall not be included as a “picked” item, and shall not be included in the Merchandise Prizes won or awarded during the Dash Event unless “picker” also pulls and places the item in the cart.
- The team will have twenty (20) minutes before the DASH to walk the aisles designated as the Dash Event Course and to develop their plan for which items they wish to select.
- A Contestant, or guest, may request a Proxy prior to the first Contestant's DASH and such Proxy must be eighteen (18) years or older to participate in a DASH.
- Merchandise is available only from the aisles designated as the Dash Event Course. Any other warehouse area is considered outside of the Dash Event Course and is not available for selection. Marking or tagging of the merchandise, floor, racking, etc. before the start of the Dash Event is not allowed.
- A team may only select a single quantity of each item.
- Only one (1) team will be on the Dash Event Course at a time. When the team is ready, a whistle will be blown to alert the team that they may begin and stop watches will start with ninety seconds (:90) on the clock. The team may begin to dash up and down the aisles putting as much merchandise into its cart as possible.
- Referees will be stationed throughout the Dash Event Course with stop watches to alert the team of their remaining DASH time. When the team's ninety seconds (:90) is up, a referee will inform them, and another whistle will be blown to alert the team to stop. At this time, no more items can be “picked.”
- The team will then take their cart(s) to the designated area where items selected will be verified immediately.

- Except as otherwise provided for herein or in the official Event Details (defined below), the Prizewinner shall be allowed to keep all items the “picker” places in their cart as the Merchandise Prizes.
- The Prizewinner will be provided a list of his or her Merchandise Prizes for their review prior to their departure from the warehouse.

## DOUBLE JACKPOT WHEEL SPIN BONUS GAME

After all DASHES are completed at each Dash Event, the Prizewinners will participate in the Bonus Game, also called the Double Jackpot Wheel Spin Bonus Game for the chance to win a cash prize from \$500 up to \$2,000,000. The Bonus Game consists of two (2) rounds:

- Round #1 Envelope Selection:
  - Each Prizewinner will randomly select a secure envelope of identical outward appearance and weight (the “**Envelope**”), each numbered one (1) through twelve (12). Each Prizewinner will receive either a “Cash Prize” message, or a “Jackpot Spin” message.

The twelve (12) envelopes will each contain one (1) of the following messages:

- Four (4) envelopes will contain a \$500 Cash Prize message;
- Four (4) envelopes will contain a \$1,000 Cash Prize message;
- Two (2) envelopes will contain a \$5,000 Cash Prize message;
- One (1) envelope will contain a \$10,000 Cash Prize message; and
- One (1) envelope will contain the “Jackpot Spin” message.

- Prizewinners will open their envelopes at the same time. If a cash prize message (the “**Cash Prize**”) is revealed, the Prizewinner will win the Cash Prize amount shown and their game play will end. The Prizewinner with the envelope containing the “Jackpot Spin” message, will move onto Round #2 as the Finalist (the “**Jackpot Contestant**”).

- Round #2 Double Jackpot Wheel Spin:
  - The Jackpot Contestant will have the chance to spin a wheel (the “**Jackpot Wheel**”) up to two (2) times.
  - The Jackpot Wheel will contain thirty-two (32) equally sized segments with one (1) segment containing the word “JACKPOT” and the remaining thirty-one (31) segments will each contain dollar amounts (the “**Wheel Prizes**”) ranging from \$100,000 to \$190,00 as follows:

- Round #2 - Spin #1:
  - If the Jackpot Contestant's first spin rests on the "JACKPOT" segment, the Jackpot Contestant will win two hundred thousand dollars (\$200,000) and will spin the Jackpot Wheel a second time; or
  - If the Jackpot Contestant's first spin rests on any dollar amount segment, the Jackpot Contestant will win the Wheel Prize shown on the segment on which the Jackpot Wheel landed ranging from \$100,000 to \$190,000 and the Bonus Game play ends.
  
- Round #2 - Spin #2:
  - If the Jackpot Contestant's first spin landed on the "JACKPOT" segment, the Jackpot Contestant will spin the Jackpot Wheel again;
  - If the Jackpot Contestant's second spin lands on "JACKPOT" again, the Jackpot Contestant will win the \$2,000,000 (the "**Jackpot Prize**") and the Bonus Game play ends; or
  - If the Jackpot Contestant's second spin rests on any dollar amount segment, the Jackpot Contestant will win the Wheel Prize shown on the segment which will be added to the \$200,000 from Spin #1 and the Bonus Game play ends.
  - All cash prizes awarded in the Bonus Game, Round #1 and Round #2, are collectively the "**Bonus Game Cash Prizes**".
  - Odds of landing on the "JACKPOT" segment in two (2) spins and winning the Jackpot Prize is 1:1,024.

**Additional Conditions:**

- All Prizewinners, Contestants, and guests must comply with the official promotional ULTIMATE DASH® Challenge Official Details (the “**Event Details**”) throughout the Dash Event and Bonus Game. Failure to do so may result in disqualification and/or forfeiture of any and all prizes won.
- Bonus Game Cash Prizes are NOT annuitized prizes.
- All Bonus Game Cash Prizes won by the Prizewinners will be subject to the LOTTERY’s debt setoff procedures.
- A Bonus Game Cash Prize is not considered won and is not payable unless and until the SG and SCA certifies that the Bonus Game has been conducted appropriately and in accordance with the Event Details and that a Prizewinner has validly won a Bonus Game Cash Prize pursuant to the Event and Security Procedures and is entitled to receive such Bonus Game Cash Prize. Payment to the winner will be made directly by the LOTTERY.
- All Merchandise Prizes won during the DASH Event will be inventoried by HINDA and then shipped by HINDA to the respective Prizewinner’s address as listed on the Prizewinners’ Trip Package claim and waiver forms within twenty-five (25) business days following the Dash Event. In the event that any Merchandise Prize(s) won during the DASH experience are damaged or defective upon receipt thereof by the Prizewinner, the Prizewinner must notify HINDA within thirty (30) calendar days from Prizewinner’s receipt of the Merchandise Prizes won in order for the damaged or defective items to be replaced by HINDA.
- If a Merchandize Prize selected during a DASH is unable to be delivered within twenty-five (25) business days, SG and HINDA, will provide a comparable prize of equal or greater value.
- The Dash Event is subject to change and should there be a delay or cancellation of a Dash Event, SG, MDI and HINDA will shall work with the LOTTERY and use their best efforts to reschedule and fulfill the Dash Event.
- FAILURE TO COMPLY WITH ANY OF THE OFFICIAL PROMOTION AND/OR EVENT DETAILS, EVENT AND SECURITY PROCEDURES, INDIVIDUAL EVENT GUIDELINES, ANY OTHER GUIDELINES, OR CODES OF CONDUCT SET FORTH BY SG, HINDA AND SCA, AND, WHEN WARRANTED, IN CONSULTATION WITH THE LOTTERY, MAY RESULT IN A PRIZEWINNER’S DISQUALIFICATION AND/OR THE REVOCATION OF ANY PRIZE WON AT THE DASH EVENT AND IN SCA’S SOLE AND ABSOLUTE DISCRETION ON THE REVOCATION OF ANY BONUS GAME JACKPOT PRIZE.

### **Entry Eligibility Requirements**

A valid entry shall follow the entry requirements herein and require a qualifying ULTIMATE DASH® Instant Scratch-Off Game (Instant Game #929) meeting the validation requirements of the NCEL. Entrants who opted to enter will receive one entry per qualifying ticket as entered into any particular entry drawing period.

1. Players may only enter the drawing by accessing the NCEL's Lucke-Rewards website at [www.nclottery.com](http://www.nclottery.com) and entering the required player information and the twenty-four (24) digit numeric entry number (which includes the game, pack, ticket number and the 12-digit validation number) from one (1) qualifying ULTIMATE DASH® Instant Scratch-Off Game (Instant Game #929). Players will be required to select whether they desire to enter the ULTIMATE DASH® second chance drawing and Promotion by opting in or out. Players may also enter the drawing by using the [NC Lottery Official Mobile App](#) to scan the barcode underneath the scratch-off coating from one (1) qualifying ULTIMATE DASH® Instant Scratch-Off Game (Instant Game #929) and selecting the option to enter into the drawing Promotion.
  - The NCEL and its vendor(s) will not be responsible for data entry errors by entrants nor for connectivity issues involving the player's access to the NCEL's website or the Mobile App.
  - An attempt to electronically submit an entry that has already been submitted will generate an error message informing the player that the entry has already been submitted and may not be resubmitted.
2. Entrants must be at least eighteen (18) years old to participate in this Promotion.
3. Entrants are subject to all NCEL Rules and Regulations, the North Carolina State Lottery Act, all other applicable laws, NCEL Terms of Service and Use, the drawing procedures for this Promotion, the Event Details, and HINDA, SG, and SCA rules and requirements. This Drawing Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law.
4. Employees of the North Carolina State Lottery Commission, NeoPollard Interactive ("NPI"), Pollard Banknote Limited ("PBL"), Scientific Games, LLC ("SG"), IGT Global Solutions Corporation ("IGT"), Spurrer Group, MDI Entertainment, LLC ("MDI"), Cactus Communications, Inc. ("Cactus"), Hinda, Inc. ("HINDA") and its affiliates, including Engage2Excel ("E2E"), SCA Promotions, Inc. ("SCA") and McConnell Jones LLC, and excluded members of their respective households, are prohibited from participating in this Second Chance Drawing Promotion. This prohibition shall also apply to any employees, and excluded members of their respective households, of companies that are associated with the game development and/or drawing process in any way. Excluded members of households are further described in NCEL Policy 9.03.
5. **The Internet and Mobile App entry methods are the only methods of entry into this second chance drawing promotion. Entries sent via any other method, US mail/courier, drop-off, etc., will be disqualified.**
6. Entries received after the entry deadline date for any drawing shall be entered into the following drawing except tickets received after the deadline date for the final Drawing (Drawing # 2). Entries received after the drawing deadline for the final drawing (Drawing #2), shall be deemed ineligible for the ULTIMATE DASH® Challenge Second Chance drawings and Promotion and shall be destroyed per the NCEL's Records Retention

Policy. Non-selected entries shall also be destroyed per the retention and destruction schedule.

7. Entries are valid for one (1) official second chance drawing in this promotion. Players may submit more than one (1) entry in each drawing. Players may win only one (1) ULTIMATE DASH® Trip Prize Package during the entire ULTIMATE DASH® Challenge Promotion.
8. Tickets determined to be in a stolen/missing inventory status or not part of a valid sold, activated or promotional NCEL inventory status will be disqualified.
9. Tickets will continue to be sold after the drawing promotion based on the availability of other cash prizes.
10. The odds of winning are dependent upon total entries into the **ULTIMATE DASH® Challenge Second Chance Promotion**.

### **Claiming Requirements**

1. The prizes for this second chance drawing promotion are not transferable or assignable unless otherwise specified or required by law.
2. All drawing entries are subject to validation by the NCEL and may be disqualified if eligibility requirements are not met.

Second Chance Drawing Prize Winners: The Trip Package Prize Package Winners of this second chance drawing promotion must complete a Winner Claim Form at the NCEL Headquarters within ten (10) days from the first notification date by the NCEL. At least three (3) attempts will be made to contact the selected entrants by email, phone call, and/or other methods of contact at the discretion of the NCEL. If winners fail to claim their prize within the ten (10) calendar day period, the NCEL will select a replacement winner from the drawing alternates. The Second Chance Drawing Prize Winners are subject to minimum Federal and State taxes and other State withholdings, as required by law. The NCEL will issue IRS Form W-2G to the Second Chance Drawing Prize Winners for prizes above \$599.
4. Except where prohibited by law, acceptance of a prize constitutes Prize Winner's permission for the NCEL to use Prize Winner's name, photograph, likeness, voice, biographical information, statements and address (city and state) for advertising and/or publicity purposes worldwide and in all forms of media now known or hereafter developed, in perpetuity, without further compensation.



5. **LIMITATIONS OF LIABILITY:** The Sponsor is not responsible for vendor error, interruption, deletion, or delay in operations, technical interruptions, including network, telephone equipment, electronic, computer, hardware, or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry. All entries received will become property of the Sponsor and may be maintained as part of the Sponsor's Promotion records. The Sponsor reserves the right to cancel or modify the Promotion if it becomes technically or otherwise corrupted. The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Promotion; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Promotion; or to be otherwise acting in an unsportsmanlike manner. Entrants agree that the Lottery (A) shall not be responsible or liable for, and is hereby released from, any and all costs, injuries, losses or damages of any kind, including, without limitation, death and bodily injury, due in whole or in part, directly or indirectly, to participation in the Promotion and/or any Promotion-related activity, or from entrants' acceptance, receipt, possession, claiming and/or use or misuse of any prize, and (B) has not made any warranty, representation or guarantee express or implied, in fact or in law, with respect to any prize, including, without limitation, to such prize's quality or fitness for a particular purpose.
