

Wheel of Fortune Second Chance Drawing Promotion Rules and Regulations

Drawing Dates

Two (2) second chance drawings will be conducted by the North Carolina Education Lottery (“NCEL” or “Lottery”) for the Wheel of Fortune Instant Scratch-Off ticket (Instant Game #048) and Wheel of Fortune Fast Play Game (Game #0043) Second Chance Drawing Promotion (“Promotion”) during the promotion entry period, as determined by the NCEL. The tentative drawing schedule for the Promotion is as follows:

Any changes will be announced by the NCEL at the earliest practical date via the NCEL’s official website (www.nc lottery.com) and the information may also be obtained by calling the Customer Support Center at (866) 934-0289.

Winners

Three (3) Real Wheel Experience Trip winners will be selected in each drawing during the promotion period. The NCEL reserves the right, in its sole discretion, to substitute any prize with an alternate prize of equal or greater value. Each winner of the Real Wheel Experience Trip shall be referred to herein as a “**Prizewinner**.”

The Real Wheel Experience Trip

The Real Wheel Experience Trip is a four-day, three-night trip for the Prizewinner and one (1) guest to Los Angeles, California (to occur TBD). Each Real Wheel Experience Trip includes:

- Round-trip airfare on a major airline, as defined by the Federal Aviation Administration, for two (2) from any continental US commercial airport to Los Angeles International Airport (LAX) in Los Angeles, California. It is the responsibility of the Prizewinner to comply with the REAL ID Act to the extent such Act is applicable to Prizewinner’s air travel.

- Luxury hotel accommodations (room and room tax only) with a minimum four-star (4-star) rating for three (3) nights and four (4) days, for two (2) persons.
- Luxury round-trip ground transportation between the airport and hotel, and the hotel and Sony Studios, for two (2) persons.
- Tour of Sony Studios for two (2) persons.

- Meet and greet and photo opportunity with show talent. Subject to show and talent approvals, restrictions and availability.
- Puzzle board photo. Subject to show approvals, restrictions and availability.
- Organized dinner, for two (2) persons with a value and other details to be determined at a later date prior to the trip date.
- Wheel of Fortune e-store gift card in an amount determined by the Lottery, which may vary by Prizewinner, to ensure that the total retail value of each Real Wheel Experience Trip is equal to ten thousand dollars (\$10,000).
- Spending money in an amount of \$1,000, less any applicable debt-setoff as determined and communicated to the Prizewinner by the Lottery. The Lottery’s fulfillment partner will mail this cash portion of the Real Wheel Experience Trip to the Prizewinner after confirmation of the amount by the Lottery and approximately two (2) weeks prior to the commencement of his or her trip in each Prizewinner’s final travel packet via signature required method. If the Prizewinner has debt setoff, the Lottery will provide fulfillment partner with the prize amount less the debt owed to be issued to the Prizewinner.

Total estimated retail value of each Trip Prize is \$10,000. Except as provided in these Rules, the Trip Prize is non-transferable, non-assignable, and not redeemable for cash.

Real Wheel Experience FULFILLMENT SERVICES AND TERMS AND CONDITIONS

- Debt Setoff and Deductions. Real Wheel Experience Trip cash components are subject to debt setoff and deductions authorized by law as determined and implemented by the Lottery. The Lottery will verify that each Prizewinner has no such outstanding debt setoff

or deductions prior to notification to Brightstar that the Prizewinner has been validated and providing such validated Prizewinner's contact information. In the event debt setoff exceeds the cash components (meaning the cash and the e-store gift card amount) of the prize, Prizewinners will have the opportunity to pay off the debt or they will need to forfeit the Real Wheel Experience Trip.

All of the Real Wheel Experience Trips will take place in the Fall of 2027 and at the same time, the specific dates and travel schedules in this time frame will be subject to the Lottery's drawing schedule and Wheel of Fortune filming schedule

Real Wheel Experience Trip Prize Rules and Terms and Conditions (Additional Conditions)

- Each Prizewinner shall be responsible for the following expenses: entertainment not included in the Real Wheel Experience Trip, including alcoholic beverages; all meals with the exception of the organized dinner mentioned above; additional gratuities; hotel incidentals (i.e., telephone calls; valet services, laundry, gift shop, etc.); transportation (to the extent not included in the Real Wheel Experience Trip); travel accident, baggage and trip cancellation insurance and fees.
- Prizewinners and their guests must be at least eighteen (18) years of age.
- Each Prizewinner and/or guest must have a valid credit card or may be required to post a cash deposit for incidentals to check in to the hotel.
- Neither the Lottery nor Brightstar Global Solutions Corporation (the Lottery's Experience Trip fulfillment provider) shall be responsible for injury, loss or damage to person or property in connection with any Real Wheel Experience Trip. Prizewinners participate in the Real Wheel Experience Trip at their own risk and responsibility.
- The Prizewinner shall be responsible for and required to pay any additional costs incurred by the following changes to any Real Wheel Experience Trip: rescheduling of ticketed air transportation, change of travel companion(s), staying additional nights, adding additional travelers, upgrading transportation, upgrading hotel room, or any other applicable trip details.
- If the Prizewinner is traveling via air and fails to appear at the designated time and place of departure reasonable efforts will be used to reschedule the flight, one-time only, at the expense of the Prizewinner. If the flight is not able to be rescheduled for the same or

similar amount, then the Prizewinner forfeits all aspects of the trip portion of the Real Wheel Experience (air travel, lodging and ground transfers).

- If the Prizewinner fails to check in to the hotel when he or she arrives in Los Angeles, and the hotel no longer has availability, the Real Wheel Experience Trip shall be forfeited, with the exception of the return air travel and cash portion of the Real Wheel Experience Trip, less any tax withholdings and debt set-off.
- In the event that a Prizewinner is unable to attend the Real Wheel Experience Trip after it has been booked, the balance of the Real Wheel Experience Trip shall be forfeited, with the exception of the up to one thousand dollars (\$1,000) spending money portion of the Real Wheel Experience Trip, less any tax withholdings and debt set-off.
- Notwithstanding the fact that the Prizewinner may end his or her participation in the Real Wheel Experience Trip under these Terms and Conditions, at the time that a Prizewinner claims the Real Wheel Experience Trip, such Prizewinner shall be deemed to have taken ownership of the entire Real Wheel Experience Trip, and the full claimed value of the entire Real Wheel Experience Trip (including the value of the travel portion) shall be reported to the IRS. Accordingly, the Prizewinner may be responsible for any additional state or federal taxes resulting from the claimed Real Wheel Experience Trip, above and beyond those taxes withheld, reported and paid on the Prizewinner behalf by the Lottery to the appropriate agencies.
- Trip date and travel schedule will be dependent upon the Lottery's drawing schedule and Wheel of Fortune filming schedule.
- If the Prizewinner cancels any trip, the Real Wheel Experience Trip shall be void. There shall be no extensions, and the Prizewinner shall not receive any reimbursement for the unused trip package.
- There is no option to receive cash equivalent for the trip portion of the Real Wheel Experience Trip (air travel, lodging and ground transfers). The Prizewinner may not choose to receive the cash equivalent of the trip portion of the Real Wheel Experience Trip.
- Upon the Prizewinner being validated by the LOTTERY, title to the Real Wheel Experience Trip shall immediately pass to the Prizewinner. The Real Wheel Experience Trip is not transferable or assignable by the Prizewinner, but may be assigned by the LOTTERY.
- If a Real Wheel Experience Trip is refused by the Prizewinner or is not claimed within the timeframe determined by the LOTTERY, the LOTTERY will assign the Real Wheel Experience Trip to an alternate Prizewinner, and Brightstar shall fulfill that Real Wheel Experience Trip under the same terms and conditions as specified herein, provided that the Real Wheel Experience Trip is still available and time requirements have not elapsed;

- The Lottery and its fulfillment partner, without having any obligation to do so, may substitute a prize of equal value or better quality upon the written approval of the Lottery.

Entry Eligibility Requirements

A valid entry shall follow the entry requirements herein and require a qualifying “Wheel of Fortune” Instant Scratch-Off ticket (Instant Game #048) or “Wheel of Fortune” Fast Play game (Fast Play #0043) meeting the validation requirements of the NCEL. Entrants who opted to enter will receive one entry per qualifying ticket as entered into any particular entry drawing period.

1. Players may only enter the drawing by using the NC Lottery Official Mobile App to scan the barcode underneath the Scratch-Off coating from one (1) qualifying wheel of Fortune instant Scratch-Off Game (Instant Game # 048) or the Lucke-Rewards® barcode from one (1) qualifying Wheel of Fortune Fast Play Game (Game #0043). Players will be required to select whether they desire to enter into the Wheel of Fortune Second Chance Drawing and Promotion by opting in or out. Players may also enter the drawing by accessing the NCEL’s Lucke-Rewards® website at www.nc lottery.com, entering the required player information and the twenty-four (24) digit numeric entry number (which includes the game, pack, ticket number and the 12-digit validation number) from one (1) qualifying Wheel of Fortune instant Scratch-Off Game (Instant Game # 048) or entering the required player information and the twenty-five (25)-digit numeric entry number (Lucke-Rewards® Entry Code) from one (1) qualifying Wheel of Fortune Fast Play Game (Game #0043) and selecting the option to enter into the drawing Promotion.
 - The NCEL and its vendor(s) will not be responsible for data entry errors by entrants nor for connectivity issues involving the player’s access to the NCEL’s website or the Mobile App.
 - An attempt to electronically submit an entry that has already been submitted will generate an error message informing the player that the entry has already been submitted and may not be resubmitted.
2. Entrants must be at least eighteen (18) years old to participate in this Promotion.
3. Entrants are subject to all NCEL Rules and Regulations, the North Carolina State Lottery Act, all other applicable laws, NCEL Terms of Service and Use, and the drawing procedures for this Promotion. This Drawing Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law.
4. Employees of the North Carolina State Lottery Commission, Aristocrat Leisure Limited, Pollard Banknote Limited (“PBL”), NeoPollard Interactive (“NPi”); Scientific Games, LLC (“SG”), Brightstar Global Solutions Corporation, Preston CPA, Cactus Communications, Inc. (“Cactus”), Sony Pictures Consumer Products Inc, Califon Productions, Inc, and excluded members of their respective households, are prohibited from participating in this Lucke-Rewards® Drawing Promotion. This prohibition shall

also apply to any employees, and excluded members of their respective households, of companies that are associated with the game development and/or drawing process in any way. Excluded members of households are further described in NCEL Policy 9.03.

5. **The Internet and Mobile App entry methods are the only methods of entry into this second chance drawing promotion. Entries sent via any other method, US mail/courier, drop-off, etc., will be disqualified.**
6. Entries received after the entry deadline date for any drawing shall be entered into the following drawing except tickets received after the deadline date for the final Drawing (Drawing # 2). Entries received after the drawing deadline for the final drawing (Drawing #2), shall be deemed ineligible for the Second Chance Drawings and Promotion and shall be destroyed per the NCEL's Records Retention Policy. Non-selected entries shall also be destroyed per the retention and destruction schedule.
7. Entries are valid for one (1) official second chance drawing in this promotion. Players may submit more than one (1) entry in each drawing. Players may win only one (1) Real Wheel Experience Prize during the entire Second Chance Promotion.
8. Tickets determined to be in a stolen/missing inventory status or not part of a valid sold, activated or promotional NCEL inventory status will be disqualified.
9. Tickets will continue to be sold after the drawing promotion based on the availability of other cash prizes.
10. The odds of winning are dependent upon total entries into the **Second Chance Promotion**.

Claiming Requirements

1. The prizes for this Second Chance Drawing and Promotion are not transferable or assignable unless otherwise specified or required by law.
2. All drawing entries are subject to validation by the NCEL and may be disqualified if eligibility requirements are not met.
3. Second Chance Drawing Prize Winners: The Trip Prize Package Winners of this second chance drawing promotion must complete a Winner Claim Form at the NCEL Headquarters within thirty (30) days from the first notification date by the NCEL. At least three (3) attempts will be made to contact the selected entrants by email, phone call, and/or other methods of contact at the discretion of the NCEL. If winners refuse the Trip Prize Package or fail to claim their prize within the thirty (30) calendar day period, the NCEL will select a replacement winner from the drawing alternates. The Second Chance Drawing Prize Winners are subject to minimum Federal and State taxes and other State

withholdings, as required by law. The NCEL will issue IRS Form W-2G to the Second Chance Drawing Prize Winners for prizes above \$599.

General Information

1. Except where prohibited by law, acceptance of a prize constitutes Prize Winner's permission for the NCEL to use Prize Winner's name, photograph, likeness, voice, biographical information, statements and address (city and state) for advertising and/or publicity purposes worldwide and in all forms of media now known or hereafter developed, in perpetuity, without further compensation, notification, or approval unless prohibited by law.
2. **LIMITATIONS OF LIABILITY:** The Sponsor is not responsible for vendor error, interruption, deletion, or delay in operations, technical interruptions, including network, telephone equipment, electronic, computer, hardware, or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry. All entries received will become property of the Sponsor and may be maintained as part of the Sponsor's Promotion records. The Sponsor reserves the right to cancel or modify the Promotion if it becomes technically or otherwise corrupted. The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Promotion; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Promotion; or to be otherwise acting in an unsportsmanlike manner. Entrants agree that the Lottery (A) shall not be responsible or liable for, and is hereby released from, any and all costs, injuries, losses or damages of any kind, including, without limitation, death and bodily injury, due in whole or in part, directly or indirectly, to participation in the Promotion and/or any Promotion-related activity, or from entrants' acceptance, receipt, possession, claiming and/or use or misuse of any prize, and (B) has not made any warranty, representation or guarantee express or implied, in fact or in law, with respect to any prize, including, without limitation, to such prize's quality or fitness for a particular purpose.

4. These Rules and all terms and conditions of this Promotion are subject to change, at any time, in the NCEL's sole discretion.
5. **GOVERNING LAW:** This Promotion shall be governed by the laws of the State of North Carolina without regard to conflict of law provisions. Any legal proceedings regarding this Promotion shall be conducted solely in a state or federal court located in Wake County, North Carolina.
