

**“Corvette And Cash” Giveaway Promotion**

OFFICIAL RULES:

1. PROMOTION PERIOD: The North Carolina Education Lottery (“Sponsor”) Corvette And Cash Giveaway Promotion (“Promotion”) begins on Thursday, July 15, 2021 at 12:00 a.m. Eastern Time (“ET”) and will end on Tuesday, July 20, 2021 at 11:59 p.m. ET (“Promotion Period”). The Promotion will include one (1) Promotion Entry Period. During the Promotion Period, Sponsor will publish one (1) post to its official Facebook page (<https://facebook.com/nclottery>), which will announce the start of the Promotion Period. At the conclusion of the Promotion Period, the Sponsor will conduct one (1) drawing with twenty-five (25) winners to win the prizes as set forth below. (“Prize”).

All comments on the Promotion Post will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

2. ELIGIBILITY: Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the [NCEL social media policy](#). Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, OKRP, Spurrier Group and MDI Entertainment, LLC, and members of their respective households, are prohibited from participating in this Promotion.
3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona on the Promotion Post during the Promotion. All entries must be

submitted within the Promotion Entry Period for the drawing. Winners will be randomly selected from the following methods of entry:

**FACEBOOK:** Users enter with a comment answering the question “Where would you go in a brand new Corvette Stingray?”. A valid entry shall be defined as the first comment meeting the eligibility requirements made by a user on the official Facebook Promotion Post during the Promotion Period. Responses made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook as determined by the Sponsor and adhering to the NCEL social media policy.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

**WINNERS & PRIZE:** Odds of winning a drawing depend on the number of valid entries received for this Promotion. Valid entries will be collected via qualified comments on the Promotion’s Facebook post at the conclusion of the Promotion Period. Twenty-five (25) entrants will be randomly selected in the drawing to win a Prize. Total Estimated Retail Value (“ERV”) of each Prize is \$500. Total ERV of all Prizes awarded is \$12,500. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be announced in a Facebook post and notified by direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize and the prize will be awarded to an alternate.
