## **2021 Holiday Social Media Giveaway Promotion**

A valid entry shall be defined as a comment made on the post during the specified drawing period and deemed, by the Sponsor, as adhering to the Sponsor's social media policy. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

## Promotion Post 3 (December 7 - December 13, 2021)

FACEBOOK: Users enter with a comment in response to the prompt "Share your most clever wrapping job" on the Facebook Promotion Post. A valid entry shall be defined as a comment made on the post during the specified drawing period and deemed, by the Sponsor, as adhering to the Sponsor's social media policy. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.
