

March 2022 Azalea Festival Concert Ticket Promotion

OFFICIAL RULES:

1. **PROMOTION PERIOD:** The North Carolina Education Lottery (“Sponsor”) Azalea Festival Concert Ticket Promotion (“Promotion”) begins on Thursday, March 17, 2022 at 1:00 p.m. Eastern Time (“ET”) and will end on Monday, March 21, 2022 at 11:59 p.m. ET. The Promotion will include one (1) drawing to be held at the conclusion of the entry period for three (3) winners who will each receive two (2) tickets to all 3 of the 2022 Azalea Festival main stage concert performances (“Prize”) located in Wilmington, North Carolina. Each prize will include six (6) tickets, two (2) of each to the following concerts at the Azalea Festival:
 - a. Brantley Gilbert on April 7, 2022
 - b. REO Speedwagon on April 8, 2022
 - c. Cypress Hill on April 9, 2022

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the [NCEL social media policy](#). Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. 3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. Any social persona may enter a comment in each Promotion Entry Period. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users enter by commenting on the promotion post. The post may instruct users to respond with a comment. A valid entry shall be defined as the first response made by a user during the Entry Period on the official Facebook post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in any drawing depend on the number of entries received for the drawing. Entries will be collected via comments on the Promotion's Facebook post for a combined pool of entrants for the drawing. Three (3) entrants will be randomly selected in the drawing to win a Prize. Total Estimated Retail Value ("ERV") of each Prize is \$318.00. Total ERV of all prizes awarded in this promotion is \$954.00. After a drawing is conducted and verified, eligible winners will be announced in a Facebook post and notified by direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within twenty-four (24) hours of notification, they will forfeit the prize and the prize will be awarded to an alternate.
