

## September 2022 ISO "Count The Cash" Social Media Promotion

### OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery ("Sponsor") September 2022 ISO "Count The Cash" Social Media Promotion ("Promotion") begins on Wednesday, September 7<sup>th</sup>, 2022 at 11:00 a.m. Eastern Time ("ET") and will end on Sunday, September 25<sup>th</sup>, 2022 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish two (2) "Promotion Posts" – one to its official Facebook page (<https://facebook.com/nclottery>) and one to its official Instagram page (<https://instagram.com/nclottery>). The Promotion will include two (2) drawings at the conclusion of the entry period for a total of ten (10) winners, who will each receive thirty (30) \$10 Hamilton scratch-off tickets (Game #850) in the value of \$300 ("Prize").

The comments on the promotional post will be exported at the end of the entry period. Promotion details including actual drawing date are subject to change at the sole discretion of the Sponsor.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. 3. **HOW TO ENTER:** There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. Any social persona may

enter a comment in each Promotion Entry Period but may only win one prize. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

**FACEBOOK:** Users enter by commenting on the promotion post. The post will instruct users to respond with a comment providing the amount of cash they counted in the promotional video. A valid entry shall be defined as the first response made by a user during the Entry Period on the official Facebook post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

**INSTAGRAM:** Users enter by commenting on the promotion post. The post will instruct users to respond with a comment providing the amount of cash they counted in the promotional video. A valid entry shall be defined as the first response made by a user during the Entry Period on the official Instagram post. Responses made on other Instagram posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

**WINNERS & PRIZE:** Odds of winning in this drawing depend on the number of entries received for that drawing. Entries will be collected via qualified comments on the Promotion's Facebook post at the end of each Entry Deadline period for the drawing. Five (5) entrants will be randomly selected in each drawing to win a Prize, for a total of ten (10) Promotion winners. Total Estimated Retail Value ("ERV") of each Prize is \$300. Total ERV of all prizes in this Promotion is \$3,000. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After the drawings are conducted and verified, eligible winners will be announced on the respective promotional Facebook and Instagram posts and will be notified by direct message via Facebook or Instagram, respectively.
