

July 2022 “How Art Thou Bold?” Social Media Promotion

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) July 2022 ISO “How Art Thou Bold?” Social Media Promotion (“Promotion”) begins on Wednesday, July 6, 2022 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, July 24, 2022 at 11:59 p.m. ET. During the Promotion Period, players will visit the “How Art Thou Bold” promotion website (<https://woobox.com/uhrutj>), where a visitor may participate in the web activity and complete the entry form. The Promotion will include one (1) drawing at the conclusion of the entry period for a total of ten (10) winners who will each receive ten (10) Fabulous Fortune scratch-off tickets (Game #842) in the value of \$300 (“Prize”).

By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. The form fields include the user’s full name and email address and confirming they meet the eligibility requirements. All entries must be submitted via the promotion website during the Drawing Entry Period to be eligible for the drawing.

PROMOTION WEBSITE: Users will enter by completing the “How Art Thou Bold” personality quiz web activity on the promotion website (<https://woobox.com/uhrutj>) and entering their full name and email address. A valid entry shall be defined as the first entry received per email address.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in this drawing depend on the number of entries received for that drawing. Entries will be collected via qualified form submissions on the “How Art Thou Bold?” promotion website. Ten (10) entrants will be randomly selected to receive a Prize.
