

**“Line Up Your Luck” January 2022 Promotion**

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) Line Up Your Luck Promotion (“Promotion”) begins on Tuesday, January 4, 2022 at 1:00 p.m. Eastern Time (“ET”) and will end on Saturday, January 15, 2022 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish one (1) “Promotion Post” to its official Facebook page (<https://facebook.com/nclottery>). The Promotion will include one (1) drawing on Facebook at the conclusion of the entry period for a total of five (5) winners who will each receive an assortment of forty (40) scratch-off tickets in the value of \$280 (“Prize”).

The comments on the promotional post will be exported at the end of the entry period. The actual drawing date is subject to change at the sole discretion of the Sponsor.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, Cactus Communications Inc., Spurrier Group and MDI Entertainment, LLC, BrkThru Digital, and members of their respective households, are prohibited from participating in this Promotion.
3. **HOW TO ENTER:** There is a limit of one (1) eligible comment entry per social persona for the specified entry period during the Promotion. Any social persona may enter a

comment in the Promotion Entry Period. All entries must be submitted within the Drawing Entry Period for the drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

Winners will be randomly selected from the following method of entry:

**FACEBOOK:** Users enter by commenting with a photo containing a screenshot of our social media game on the promotion post. A valid entry shall be defined as the first media comment meeting the eligibility requirement made by a user during the specified time period on the official Facebook post. Responses made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook as determined by the Sponsor and adhering to the NCEL social media policy. Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

**WINNERS & PRIZE:** Odds of winning in this drawing depend on the number of entries received for that drawing. Entries will be collected via qualified comments on the Promotion's Facebook post at the end of each Entry Deadline period for the drawing. Five (5) entrants will be randomly selected to win a Prize. Total Estimated Retail Value ("ERV") of the Prize is \$280. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be announced in a Facebook post and notified by direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name, North Carolina mailing address, birthdate, phone number and email address to the Sponsor's notification via Facebook, they may be disqualified and the prize will be awarded to an alternate.
