

## May 2022 NCEL 200 Race Speed Street Giveaway Promotion

### OFFICIAL RULES:

1. **PROMOTION PERIOD:** The North Carolina Education Lottery (“Sponsor”) NCEL 200 Race Speed Street Ticket Giveaway Promotion (“Promotion”) begins on Wednesday, May 11<sup>th</sup>, 2022 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, May 15<sup>th</sup>, 2022 at 11:59 p.m. ET. The Promotion will include two (2) drawings to be held at the conclusion of the entry period for twenty (20) winners. Each winner will receive four (4) tickets to the NCEL 200 Race Event (“Prize”) that takes place on Friday, May 27<sup>th</sup>, 2022 at Charlotte Motor Speedway in Concord, North Carolina. The tickets will allow winners to gain entry to the NCEL 200 Race, as well as attend the Flo Rida concert on the evening of May 27<sup>th</sup>, 2022.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. 3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. INSTAGRAM: Users enter by commenting on the promotion post. The post may instruct users to respond with a comment. A valid entry shall be defined as the first response made by a user during the Entry Period on the official Instagram post. Responses made on other Instagram posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in any drawing depend on the number of entries received for the drawing. Entries will be collected via comments on the Promotion's Facebook post for a combined pool of entrants for the first drawing, and via comments on the Promotion's Instagram post for a combined pool of entrants for the second drawing. Ten (10) entrants will be randomly selected in each drawing to win a Prize, for a total of twenty (20) winners in the Promotion. Total Estimated Retail Value ("ERV") of each Prize is \$140.00. Total ERV of all prizes awarded in this promotion is \$2,800. Prizes are not transferable, assignable, or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be announced in a Facebook post and notified by direct message via Facebook.
