

September 2022 Bank of America ROVAL 400 Ticket Giveaway Promotion

OFFICIAL RULES:

1. PROMOTION PERIOD: The North Carolina Education Lottery (“Sponsor”) Bank of America ROVAL 400 Ticket Giveaway Promotion (“Promotion”) begins on Thursday, September 1st, 2022 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, September 11th, 2022 at 11:59 p.m. ET. The Promotion will include two (2) drawings to be held at the conclusion of the entry period, each drawing will select five (5) winners for ten (10) total winners. Each winner will receive two (2) tickets to the Bank of America ROVAL 400 Race Event (“Prize”) that takes place on Sunday, October 9th, 2022 at Charlotte Motor Speedway in Concord, North Carolina.
