

“Whose Wooo Is Whose?” February 2022 Promotion

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) Whose Wooo Is Whose (“Promotion”) begins on Friday, February 4th, 2022 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, February 20th, 2022 at 11:59 p.m. ET. During the Promotion Period, players will visit the “Whose Wooo Is Whose” promotion website (www.whosewooiswhose.com) where a visitor may participate in the web activity and complete the entry form. The Promotion will include one (1) drawing at the conclusion of the entry period for a total of ten (10) winners who will each receive a pack of scratch-off tickets in the value of \$300 (“Prize”) as outlined below.

No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, and the drawing procedures. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. 3. HOW TO ENTER: Users enter by completing the entry form on the promotion website (www.whosewooiswhose.com). The form fields include the user's full name and email address and confirming they meet the eligibility requirements. There is a limit of one (1) eligible entry per email address for the specified entry period during the Promotion. All entries must be submitted via the promotion website during the Drawing Entry Period to be eligible for the drawing.

Winners will be randomly selected from the following method of entry:

PROMOTION WEBSITE: Users will enter by completing the "Whose Woo is Whose" web activity on the promotion website (whosewooiswhose.com) and entering their full name and email address. A valid entry shall be defined as the first entry received per email address.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in this drawing depend on the number of entries received for that drawing. Entries will be collected via qualified form submissions on the "Whose Woo is Whose" promotion website. Ten (10) entrants will be randomly selected to win a Prize. Total Estimated Retail Value ("ERV") of the Prize is \$300. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be contacted via the email provided upon entry. If selected entrants do not respond to the notification directing them to contact the Sponsor within seventy-two (72) hours of notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met.
