

October 2022 Winning Moves Social Media Promotion

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) October 2022 Winning Moves Promotion (“Promotion”) begins on Wednesday, October 5, 2022 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, October 23, 2022 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish two (2) “Promotion Posts” – one to its official Facebook page (<https://facebook.com/nclottery>) and one to its official Instagram page (<https://instagram.com/nclottery>). The Promotion will include two (2) drawings at the conclusion of the entry period for a total of ten (10) winners who will each receive ten (10) Mega 7’s scratch-off tickets (Game #854) in the value of \$200.00. (“Prize”).

The comments on the promotional post will be exported at the end of the entry period. Promotion details including actual drawing date are subject to change at the sole discretion of the Sponsor.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Any social persona may enter a comment in each Promotion Entry Period but may only win one prize. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

FACEBOOK: Users enter by commenting on the promotion post. The post will instruct users to respond with a comment sharing their "winning move" name created from the Winning Move Generator. A valid entry shall be defined as the first response made by a user during the Entry Period on the official Facebook post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

INSTAGRAM: Users enter by commenting on the promotion post. The post will instruct users to respond with a comment sharing their "winning move" name created from the Winning Move Generator. A valid entry shall be defined as the first response made by a user during the Entry Period on the official Instagram post. Responses made on other Instagram posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in this drawing depend on the number of entries received for that drawing. Entries will be collected via qualified comments on the Promotion's Facebook and Instagram posts at the end of each Entry Deadline period for the drawing. Five (5) winners will be randomly selected from each post, for a total of ten (10) entrants randomly selected to win a Prize. Total Estimated Retail Value ("ERV") of each Prize is \$200.00. Total ERV of all prizes in this Promotion is \$2,000.00. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be announced on the Promotion Posts on Facebook and Instagram and will be notified via direct message on the corresponding social platform. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name, North Carolina mailing address,

birthdate, phone number and email address to the Sponsor's notification via Facebook or Instagram, they may be disqualified and the prize will be awarded to an alternate.
