

December 2023 \$10 Million Spectacular Cash Launcher Promotion

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) December 2023 \$10 Million Spectacular Cash Launcher Promotion (“Promotion”) begins on Tuesday, December 5th, 2023 at 12:00 a.m. Eastern Time (“ET”) and will end on Monday, January 1st, 2024 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish one (1) “Promotion Post” to its official Facebook page (<https://facebook.com/nclottery>), where players will share a photo taken with the \$10 Million Spectacular Augmented Reality Experience. The Promotion will include one (1) entry period and one (1) drawing at the conclusion of the entry period for a total of twenty (20) winners, who will each receive ten (10) \$10 Million Spectacular scratch-off tickets (Game #913) (“Prize”). Estimated Retail Value (“ERV”) of each Prize is \$500.00. ERV of all Prizes in the Promotion is \$10,000.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the Draw Date.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number, and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. 3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for the specified Promotion Entry Period during the Promotion. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users will enter with a comment on the official Facebook promotion entry post (the "Promotion Post") during the Promotion Entry Period sharing a photo taken with the \$10 Million Spectacular Cash Launcher Augmented Reality Experience. A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in this drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Facebook post at the end of the Entry Deadline period for the drawing. Twenty (20) winners will be randomly selected from the list of entrants to receive a Prize. ERV of each Prize in this Promotion is \$500. Total ERV of all prizes in this Promotion is \$10,000.
