

2023 Carolina Panthers Champions Village Social Media Giveaway

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) 2023 Carolina Panthers Champions Village Social Media Giveaway (“Promotion”) begins on Wednesday, October 25th, 2023 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, October 29th, 2023 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish one (1) “Promotion Post” to its official Facebook page (<https://facebook.com/nclottery>). The Promotion will include one (1) drawing at the conclusion of the entry period for a total of five (5) winners, who will each receive two (2) Champions Village gameday tickets for the Carolina Panthers game at Bank of America Stadium in Charlotte, NC on Sunday, December 17th (“Prize”). Estimated Retail Value (“ERV”) of this Prize is \$3,200.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number, and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, Cactus Communications Inc., Spurrier Group, MDI Entertainment, LLC,

For prizes with an ERV of \$600 or more, debt setoff will be deducted from cash awarded, if any, in accordance with NC Gen. Stat. § 18C-134. If cash awarded is not sufficient to cover the debt, winner must satisfy the debt within 5 business days. In the event a winner does not satisfy all debt reported to the NCEL under NC Gen. Stat. § 18C-134 within the time allotted, that winner forfeits their prize and it will be awarded to an alternate winner. In the event a winner declines the prize, the winner must submit a prize forfeiture form within 5 business days or the winner forfeits their prize and it will be awarded to an alternate.

3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for the specified Promotion Entry Period during the Promotion. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users will enter with a comment on the official Facebook promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in this drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Facebook post at the end of the Entry Deadline period. Five (5) winners will be randomly selected to receive a Prize, for a total five (5) winners in the Promotion. Total ERV of each Prize is \$3,200. Total ERV of all prizes in this Promotion is \$16,000.

The prize package is subject to mandatory taxes and other State withholdings, as required by law. Mandatory fees and tax withholdings will be paid by the Sponsor. The prize package value is \$3,200, not including taxes and fees. The NCEL will remit

the minimum required tax withholdings to the appropriate agency and issue the W-2G form to the winner.

Winner of the Carolina Panthers Champions Village Giveaway will receive their tickets and instructions for accessing Champions Village from the NCEL via email to the email address provided by the winner. Failure to claim Champions Village hospitality as instructed does not change the value of the Prize or the amount reported on the W-2G form.

The NCEL is not responsible for any additional State tax and/or any applicable Federal and local taxes.

Prizes are not transferable, assignable, or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be notified by comment reply or direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within 48 hours of notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name, North Carolina mailing address, birthdate, phone number and email address to the Sponsor's notification via Facebook, they may be disqualified and the prize will be awarded to an alternate.

Completed Claim Form can be submitted by email with a Valid State-issued ID, through the Lucke-Rewards Secure Document Upload on the NC Lottery website, or claimed at one of the Sponsor's regional offices. The winner must submit a Winner Claim Form within ten (10) days from the first notification date by the NCEL. At least 3 attempts will be made to contact the selected entrant by email, phone call, and/or other methods of contact at the discretion of the NCEL. If winners fail to claim their

prize within the ten (10) calendar day period, the NCEL will select a replacement winner from the drawing alternates.
