

March 2023 Charlotte Hornets Fan Experience Giveaway Promotion

OFFICIAL RULES:

1. **PROMOTION PERIOD:** The North Carolina Education Lottery (“Sponsor”) Charlotte Hornets Fan Experience Giveaway Promotion (“Promotion”) begins on Wednesday, March 15th, 2023 at 12:00 a.m. Eastern Time (“ET”) and will end on Monday, March 20th, 2023 at 11:59 p.m. ET. The Promotion will include one (1) drawing to be held at the conclusion of the entry period, the drawing will select one (1) winner. The winner will receive two (2) lower-level tickets in Royal Box 21 for the Charlotte Hornets vs. Houston Rockets basketball game on April 7th, 2023 at 7:00 PM at Spectrum Center in Charlotte, NC, access to the “Flight Deck” with a complimentary dinner, an autographed LaMelo Ball jersey, and a \$200 VISA gift card (“Prize”). Estimated Retail Value (“ERV”) of this prize is \$1,629.72.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Stat. § 18C-134 within the time allotted, that winner forfeits their prize and it will be awarded to an alternate winner.

3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. Any social persona may enter a comment in each Promotion Entry Period but may only win one prize. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

FACEBOOK: Users enter by commenting on the promotion post. The post will instruct users to respond with a comment sharing who they would bring with them to the game. A valid entry shall be defined as the first response made by a user during the Entry Period on the official Facebook post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in any drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Facebook post at the end of the Entry Deadline period for the drawing. One (1) entrants will be randomly selected in the drawing to win a Prize, for a total of one (1) winner in the Promotion. The prize package is subject to mandatory taxes and other State withholdings, as required by law. Mandatory fees and tax withholdings will be paid by the Sponsor. The prize package value is \$1,629.72, not including taxes and fees. The NCEL will remit the minimum required tax withholdings to the appropriate agency and issue the W-2G form to the winner.

Winner of the Charlotte Hornets Fan Experience will receive tickets and instructions to enter the Flight Deck Lounge from the NCEL via email to the email address provided

by the winner. Failure to claim lounge access as instructed does not change the value of the Prize or the amount reported on the W-2G form.

The NCEL is not responsible for any additional State tax and/or any applicable Federal and local taxes.

After a drawing is conducted and verified, eligible winners will be notified by comment reply or direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within 3 days of notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name, North Carolina mailing address, birthdate, phone number and email address to the Sponsor's notification via Facebook, they may be disqualified and the prize will be awarded to an alternate.
