

The FIRE VERSUS ICE Live Promotion (Live Drawings)

OFFICIAL RULES:

1. **PROMOTION PERIOD:** The North Carolina Education Lottery (“Sponsor”) The FIRE VERSUS ICE Live Promotion (“Promotion”) begins on Wednesday, January 18, 2023 at 1:00 p.m. Eastern Time (“ET”) and will end on Wednesday, January 18, 2023 at approximately 4:00 p.m. ET. The Promotional Period will include Two (2) Promotional Entry Periods during the Promotional Period to select qualified Entry holders to win a prize at the conclusion of each Promotional Entry Period. Five (5) winners will be selected during Promotional Entry Period Drawing #1 to receive Sixty (60) “FIRE” scratch-off tickets – Game Number 866 (“Prize”). Five (5) winners will be selected during Promotional Entry Period Drawing #2 to receive Sixty (60) “ICE” scratch-off tickets – Game Number 867 (“Prize”).
