2023 Men's Basketball Tournament at Greensboro Coliseum Fan Experience Promotion

OFFICIAL RULES:

1. PROMOTION PERIOD: The North Carolina Education Lottery ("Sponsor") 2023 ACC Men's Basketball Tournament at Greensboro Coliseum Fan Experience Promotion ("Promotion") begins on Monday, February 13th, 2023 at 12:00 a.m. Eastern Time ("ET") and will end on Sunday, February 19th, 2023 at 11:59 p.m. ET. The winners will each receive a Men's Basketball Tournament session ticket book, which includes: two (2) tickets to see each of the Men's Basketball Tournament games at the Greensboro Colosseum from March 7th, 2023 through March 11th, 2023, as well as parking passes for the games and a gift card in the amount of \$300. The Prize will consist of the session ticket book, parking passes, and \$300 gift card; with a total estimated retail value of \$1,000.00 ("Prize").
