

2023 Men’s Basketball Tournament at Greensboro Coliseum Fan Experience Promotion

OFFICIAL RULES:

1. **PROMOTION PERIOD:** The North Carolina Education Lottery (“Sponsor”) 2023 ACC Men’s Basketball Tournament at Greensboro Coliseum Fan Experience Promotion (“Promotion”) begins on Monday, February 13th, 2023 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, February 19th, 2023 at 11:59 p.m. ET. The Promotion will include one (1) drawing to be held at the conclusion of the entry period, the drawing will select two (2) winners. The winners will each receive a Men’s Basketball Tournament session ticket book, which includes: two (2) tickets to see each of the Men’s Basketball Tournament games at the Greensboro Colosseum from March 7th, 2023 through March 11th, 2023, as well as parking passes for the games and a gift card in the amount of \$300. The Prize will consist of the session ticket book, parking passes, and \$300 gift card; with a total estimated retail value of \$1,000.00 (“Prize”).

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations,

the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, Cactus Communications Inc., Spurrier Group and MDI Entertainment, LLC, BrkThru Digital, and members of their respective households, are prohibited from participating in this Promotion.

For prizes with an ERV of \$600 or more, debt setoff will be deducted from cash awarded, if any, in accordance with NC Gen. Stat. § 18C-134. If cash awarded is not sufficient to cover the debt, winner must satisfy the debt within 4 days. In the event a winner does not satisfy all debt reported to the NCEL under NC Gen. Stat. § 18C-134 within the time allotted, that winner forfeits their prize and it will be awarded to an alternate winner.

3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for the specified Promotion Entry Period during the Promotion. Any social persona may enter a comment in each Promotion Entry Period but may only win one prize. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

FACEBOOK: Users enter by commenting on the promotion post. The post will instruct users to respond with a comment answering the question, "What basketball team are you rooting for this year?" A valid entry shall be defined as the first response made by a user during the Entry Period on the official Facebook post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks, or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in any drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Facebook post at the end of the Entry Deadline period for the drawing. Two (2) entrants will be randomly selected in the drawing to win a Prize, for a total of two (2) winners in the Promotion. The prize package is subject to mandatory taxes and other State withholdings, as required by law. The Sponsor will pay the required fees and minimum withholding amount at the current North Carolina tax rate of

4.75%. The NCEL will remit the minimum required tax withholdings to the appropriate agency and issue the W-2G form to the winner. The Estimated Retail Value (“ERV”) of each Prize is \$1,000. The total ERV of all Prizes for this Promotion is \$2,000.

Winner of the 2023 Men’s Basketball Tournament at Greensboro Coliseum Fan Experience will receive tickets to the 2023 Tournament games from the NCEL by email to the email address provided by the winner. Parking passes and \$300 VISA Debit Gift Card will be mailed by the NCEL to the mailing address provided by the winner.

The NCEL is not responsible for any additional State tax and/or any applicable Federal and local taxes.

Prizes are not transferable, assignable, or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be notified by comment reply or direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within 48 hours of notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor’s notification within the specified deadline but fails to provide their full name, North Carolina mailing address, birthdate, phone number and email address to the Sponsor’s notification via Facebook, or fails to complete the required Claims Form for Prizes Over \$600, they may be disqualified and the prize will be awarded to an alternate.
