## February 2023 Mr. First Tuesday Valentine's Day Giveaway Promotion

## OFFICIAL RULES:

Responses made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook as determined by the Sponsor and adhering to the NCEL social media policy.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

INSTAGRAM: Users will enter with a comment describing who they will share Valentine's Day with on the official Instagram promotion entry post. (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the specified time period on the official Instagram Promotion Post. Responses made on other Instagram posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Instagram as determined by the Sponsor and adhering to the NCEL social media policy.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in this drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Facebook and Instagram posts at the end of each Entry Deadline period for each drawing. One (1) winner will be randomly selected from each post, for a total two (2) winners randomly selected to win a Prize. Total Estimated Retail Value ("ERV") of each Prize is \$300. Total ERV of all prizes in this
