

**October 2023 “Power Hour” Social Media Promotion**

**OFFICIAL RULES:**

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) October 2023 “Power Hour” Social Media Promotion (“Promotion”) begins on Tuesday, October 10<sup>th</sup>, 2023 at 12:00 p.m. Eastern Time (“ET”) and will end on Tuesday, October 24<sup>th</sup> 2023 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish three (3) “Promotion Posts” – one (1) post each Tuesday - to its official Facebook page (<https://facebook.com/nclottery>). The Promotion will include three (3) Entry Periods of one (1) hour each and one (1) drawings at the conclusion of each entry period for a total of five (5) winners, for a total of three (3) Promotion drawings and fifteen (15) Promotion winners.

Winners from the first drawing will receive sixty (60) Power 5s scratch-off tickets (Game #902), winners from the second drawing will receive sixty (60) Power Cashword scratch-off tickets (Game #903), and winners of the third drawing will receive fifteen (15) Power 20s scratch-off tickets (Game #904). ERV of each Prize is \$300 (“Prize”). ERV of all Prizes in this Promotion is \$4,500.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number, and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win.

No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, Cactus Communications Inc., Spurrier Group, MDI Entertainment, LLC, BrkThru Digital, Thomas & Gibbs CPAs PLLC, and members of their respective households, are prohibited from participating in this Promotion.

3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. Any social persona may enter a comment in each Promotion Entry Period but may only win one prize. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users will enter with a comment on the official Facebook promotion entry post during the "Power Hour" entry period and share their answer to the trivia question shared in the post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in this drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Facebook posts at the end of each Entry Deadline period for each drawing. Five (5) winners will be randomly selected from each post to receive a Prize, for a total fifteen (15) winners in the Promotion. ERV of each Prize in this Promotion is \$300. Total ERV of all prizes in this Promotion is \$4,500.

Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible

winners will be announced on the Promotion Posts on Facebook and Instagram and will be notified via direct message on the corresponding social platform. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name, North Carolina mailing address, birthdate, phone number and email address to the Sponsor's notification via Facebook or Instagram, they may be disqualified and the prize will be awarded to an alternate.

manner. The Promotion is not sponsored, endorsed, administered by, or associated with Facebook.
