July 2024 Supreme Trivia Social Media Promotion

OFFICIAL RULES:

1. ENTRY PERIOD: The North Carolina Education Lottery ("Sponsor") July 2024 Supreme Trivia Social Media Promotion ("Promotion") begins on Wednesday, July 3rd, 2024 at 12:00 a.m. Eastern Time ("ET") and will end on Monday, July 29th, 2024 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish four (4) "Promotion Posts" – one (1) post each Wednesday - to its official Facebook page (https://facebook.com/nclottery). The Promotion will include four (4) Entry Periods and one (1) drawing at the conclusion of each entry period, each for five (5) winners, for a total of four (4) Promotion drawings and twenty (20) Promotion winners. Entries will be collected via qualified comments on each of the Promotion's Facebook posts at the end of each Entry Deadline period for each drawing.
