

February 2024 zMAX NHRA 4-Wide Weekend Ticket Social Media Giveaway

OFFICIAL RULES:

1. **PROMOTION PERIOD:** The North Carolina Education Lottery (“Sponsor”) zMAX 4-Wide Weekend Ticket Social Media Giveaway (“Promotion”) begins on Thursday, February 15th, 2024 at 12:00 a.m. Eastern Time (“ET”) and will end on Tuesday, February 20th, 2024 at 11:59 p.m. ET During the Promotion Period, the Sponsor will publish one (1) “Promotion Posts” on its official Facebook page (<https://facebook.com/nclottery>). The Promotion will include one (1) drawings at the conclusion of the Entry Period for a total of two (2) winners for this Promotion. Each winner will receive two (2) tickets to the NHRA 4-Wide Nationals Weekend Event (“Prize”) that takes place on April 26-28, 2024 at the zMAX Dragway in Concord, North Carolina. Estimated Retail Value (“ERV”) of this Prize is \$280. ERV of all Prizes in this Promotion is \$560.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. 3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. Any social persona may enter a comment in each Promotion Entry Period but may only win one prize. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users will enter with a comment on the official Facebook promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the specified time period on the official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook as determined by the Sponsor and adhering to the NCEL social media policy.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

Entries will be collected via qualified comments on the Promotion's Facebook post at the end of the Entry Deadline period for the drawing. Two (2) entrants will be randomly selected in the drawing to win a Prize, for a total of two (2) winners in the Promotion. Total ERV of each Prize is \$280.00. Total ERV of all prizes awarded in this promotion is \$560.00.

Prizes are not transferable, assignable, or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be notified by comment reply or direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within 72 hours of notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name, North Carolina mailing address,

Prizes will be emailed to the email addresses provided by the winners via an electronic ticket transfer.

All winners shall be required to have, or create, a Ticketmaster account to receive their tickets and shall follow all Ticketmaster terms and conditions.
