April 2025 Carolina Hurricanes Playoff Tickets Social Media Giveaway

OFFICIAL RULES:

1. PROMOTION PERIOD: The North Carolina Education Lottery ("Sponsor") April 2025 Carolina Hurricanes Playoff Tickets Social Media Giveaway ("Promotion") begins on Wednesday, April 9th, 2025 at 12:00 a.m. Eastern Time ("ET") and will end on Monday, April 14th, 2025 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish "Promotion Posts", two (2) one on its official Facebook page (https://facebook.com/nclottery), and one on its official Instagram page (https://instagram.com/nclottery). At the conclusion of the Promotion Entry Periods, the NCEL will conduct two (2) drawings, one (1) for each Platform (Facebook and Instagram)/Promotion Entry Period, each for a total of one (1) winner, resulting in a total of two (2) winners for this Promotion. Each winner will receive two (2) tickets to the first Carolina Hurricanes home playoff game ("Prize") that takes place on a to be announced date at the Lenovo Center in Raleigh, North Carolina. Estimated Retail Value ("ERV") of each Prize is \$336.76. ERV of all Prizes in this Promotion is \$673.52.

INSTAGRAM: Users will enter with a comment on the official Instagram promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Instagram Promotion Post. Responses made on other Instagram posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

Entries will be collected via qualified comments on the Promotion's Facebook and Instagram posts at the end of each Entry Deadline period for each drawing.
