May 2025 Mr. First Tuesday Social Media Promotion Rules

OFFICIAL RULES:

 ENTRY PERIOD: The North Carolina Education Lottery ("Sponsor") May 2025 Mr. First Tuesday Social Media Promotion ("Promotion") begins on Wednesday, April 30th, 2025 at 12:00 a.m. Eastern Time ("ET") and will end on Sunday, May 4th, 2025 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish two (2) "Promotion Posts" – one to its official Facebook page (<u>https://facebook.com/nclottery</u>) and one to its official Instagram page (<u>https://instagram.com/nclottery</u>). The Promotion will include two (2) drawings at the conclusion of the Entry Periods for a total of two (2) winners, who will each receive an assortment of sixty (60) scratch-off tickets, twenty (20) of each of Games #990-992 ("Prize"). Estimated Retail Value ("ERV") of each Prize is \$540. ERV of all Prizes in this Promotion is \$1,080.

3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

INSTAGRAM: Users will enter with a comment on the official Instagram promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Instagram Promotion Post. Responses made on other Instagram posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. WINNERS & PRIZE: Odds of winning in each drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the

Promotion's Facebook and Instagram posts at the end of each Entry Deadline period for each drawing. One (1) winner will be randomly selected from each post to receive a Prize, for a total two (2) winners in the Promotion. Total ERV of each Prize is \$540. Total ERV of all prizes in this Promotion is \$1,080.

Winners are subject to minimum Federal and State taxes and other State withholdings, as required by law. The NCEL will issue a W-2G form to Prize winners for total Prize wins above \$599.

After a drawing is conducted and verified, eligible winners will be announced on Facebook and Instagram and will be notified via comment response and a direct message on the corresponding social platform. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize, and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responds to the Sponsor's notification within the specified deadline, but fails to provide their full name, North Carolina mailing address, birthdate, phone number, and email address to the Sponsor's notification via Facebook or Instagram, they may be disqualified, and the prize will be awarded to an alternate.
