

May 2025 NCEL 200 Weekend Ticket Social Media Giveaway

OFFICIAL RULES:

1. **PROMOTION PERIOD:** The North Carolina Education Lottery (“Sponsor”) May 2025 NCEL 200 Weekend Ticket Giveaway (“Promotion”) begins on Thursday, May 1st, 2025 at 12:00 a.m. Eastern Time (“ET”) and will end on Monday, May 5th, 2025 at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish two (2) “Promotion Posts” – one to its official Facebook page (<https://facebook.com/nclottery>) and one to its official Instagram page (<https://instagram.com/nclottery>). The Promotion will include two (2) drawings (one (1) drawing for each Facebook and Instagram) at the conclusion of the Entry Periods for a total of ten (10) winners, who will each receive two (2) tickets to the Coca-Cola 600 weekend event (“Prize”) that takes place on May 23rd-25th, 2025 at Charlotte Motor Speedway in Concord, North Carolina. The tickets will allow winners to attend all events throughout the weekend, including the *North Carolina Education Lottery 200* on Friday, May 23rd, the *BetMGM 300* on Saturday, May 24th, and the *Coca-Cola 600* on Sunday, May 25th. Estimated Retail Value (“ERV”) of each Prize is \$358. ERV of all Prizes in this Promotion is \$3,580.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number, and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures, and Meta rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by

law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, Cactus Communications Inc., Spurrier Group, MDI Entertainment, LLC, BrkThru Digital, Preston CPA, Charlotte Motor Speedway, NASCAR, and members of their respective households, are prohibited from participating in this Promotion.

3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. Any social persona may enter a comment in each Promotion Entry Period but may only win one prize. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users will enter with a comment on the official Facebook promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

INSTAGRAM: Users will enter with a comment on the official Instagram promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Instagram Promotion Post. Responses made on other Instagram posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. WINNERS & PRIZE: Odds of winning in each drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Facebook and Instagram posts at the end of each Entry Deadline period for each drawing. Five (5) winners will be randomly selected from each post to receive a Prize, for a total ten (10) winners in the Promotion. Total ERV of each Prize is \$358. Total ERV of all prizes in this Promotion is \$3,580.

Winners are subject to minimum Federal and State taxes and other State withholdings, as required by law. The NCEL will issue an IRS Form W-2G to Prize winners for total Prize wins above \$599.

Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be announced on Facebook and Instagram and will be notified via comment response and a direct message on the corresponding social platform. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the Prize, and the Prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responds to the Sponsor's notification within the specified deadline, but fails to provide their full name, North Carolina mailing address, birthdate, phone number, and email address to the Sponsor's notification via Facebook or Instagram, they may be disqualified, and the Prize will be awarded to an alternate. Alternate winners must meet all eligibility and prize claiming requirements.

Prizes will be emailed to the email addresses provided by the winners via an electronic ticket transfer.

All winners shall be required to have, or create, a Ticketmaster account to receive their tickets and shall follow all Ticketmaster terms and conditions. Additionally, all winners shall follow all Charlotte Motor Speedway rules and policies. Failure to follow Ticketmaster terms and conditions or Charlotte Motor Speedway rules and policies shall not void the prize and winner bears all risk associated with their failure to follow appropriate terms, conditions, rules, and policies.

The Promotion is not sponsored, endorsed, administered by, or associated with Facebook or Instagram.
