September 2025 Play Smart Hobby Hunt Promotion

OFFICIAL RULES:

The Promotion includes one (1) entry period and one (1) drawing at the conclusion of the entry period for a total of ten (10) winners, who will each receive thirty (30) \$1,000,000 Bonus Match scratch-off tickets (Game #011) ("Prize"). Estimated Retail Value ("ERV") of each Prize in this Promotion is \$300. ERV of all Prizes in this Promotion is \$3,000.

PROMOTION WEBSITE: Users may enter by completing the Hobby Hunt activity on the NC Play Smart website (https://ncplaysmart.com/wp-content/HobbyHunt/live/).
