June 2025 Triple Play Takedown Social Media Promotion

OFFICIAL RULES:

1. ENTRY PERIOD: The North Carolina Education Lottery ("Sponsor") June 2025 Triple Play Takedown Social Media Promotion ("Promotion") begins on Tuesday, June 3rd, 2025 at 12:00 a.m. Eastern Time ("ET") and ends on Sunday, June 29th, 2025 at 11:59 p.m. ET ("Promotion Period"). During the Promotion Period, players may visit the Triple Play Takedown promotion website (https://tripleplaytakedown.com), where they can participate in the web game and complete the entry form. The Promotion includes one (1) entry period and one (1) drawing at the conclusion of the entry period for a total of ten (10) winners, who will each receive an assortment of eighty (80) scratch-off tickets, twenty (20) of each of Games #993-996 ("Prize"). Estimated Retail Value ("ERV") of each Prize is \$360. ERV of all Prizes in this Promotion is \$3,600.

PROMOTION WEBSITE: Users may enter by completing the activity on the promotion website (https://tripleplaytakedown.com).
