The Promotion will include one (1) entry period and one (1) drawing at the conclusion of the entry period for a total of ten (10) winners, who will each receive an assortment of forty (40) scratch-off tickets, ten (10) of each of Games #973-976 ("Prize"). 3. HOW TO ENTER: There is a limit of one (1) eligible entry per person for the specified entry period during the Promotion. All entries must be submitted via the promotion website during the Drawing Entry Period to be eligible for the drawing.

PROMOTION WEBSITE: Users may enter by completing the Winners Club Crossword activity on the promotion website (https://WinnersClubCrossword.com).
