

**June 2026 “Guess The Phrase” Social Media Promotion Rules**

OFFICIAL RULES:

1. PROMOTION ENTRY PERIOD: The North Carolina Education Lottery (“Sponsor”) June 2026 “Guess The Phrase” Social Media Promotion (“Promotion”) begins on Tuesday, June 2<sup>nd</sup>, 2026 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, June 21<sup>st</sup>, 2026 at 11:59 p.m. ET (the “Promotion Period”). The Promotion Period will include three (3) separate Promotion Entry Periods. During each Promotion Entry Period, the Sponsor will publish two (2) posts (each a “Promotion Post”), one (1) to its official Facebook page ([facebook.com/nclottery](https://facebook.com/nclottery)) and one (1) to its official Instagram page ([instagram.com/nclottery](https://instagram.com/nclottery)), for a total of six (6) Promotion Posts. The Promotion will include three (3) Promotion Entry Periods and two (2) drawings at the conclusion of each Promotion Entry Period, each for two (2) winners, for a total of six (6) Promotion drawings and twelve (12) Promotion winners. Each winner will receive sixty (60) scratch-off tickets, twenty (20) each of Games #044-046 (“Prize”). Estimated Retail Value (“ERV”) of each Prize is \$340. ERV of all Prizes in this Promotion is \$4,080.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of each Draw Date.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number, and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures, and Meta rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Aristocrat Leisure Limited, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, Brightstar Global Solutions Corporation, Cactus Communications Inc., MDI

Entertainment, LLC, Preston CPA, and members of their respective households, are prohibited from participating in this Promotion.

3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. Any social persona may enter a comment in each Promotion Entry Period but may only win one prize. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users will enter with a comment on each official Facebook promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during each Entry Period on each official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

INSTAGRAM: Users will enter with a comment on each official Instagram promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during each Entry Period on each official Instagram Promotion Post. Responses made on other Instagram posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. WINNERS & PRIZE: Odds of winning in each drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Facebook and Instagram posts at the end of each Entry Deadline period for each drawing. Two (2) winners will be randomly selected from each post to receive a Prize, for a total twelve (12) winners in the Promotion. Total ERV of each Prize is \$340. Total ERV of all prizes in this Promotion is \$4,080.

Winners are subject to minimum Federal and State taxes and other State withholdings, as required by law. The NCEL will issue an IRS Form W-2G to Prize winners for total Prize wins above \$599.

Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be announced on Facebook and Instagram and will be notified via comment response and a direct message on the corresponding social platform. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize, and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responds to the Sponsor's notification within the specified deadline, but fails to provide their full name, North Carolina mailing address, birthdate, phone number, and email address to the Sponsor's notification via Facebook or Instagram, they may be disqualified, and the prize will be awarded to an alternate. Alternate winners must meet all eligibility and prize claiming requirements.

Selected entrants must present a valid, government-issued photo ID matching the name of the winner to claim the Prize at a Regional Office.

If an entrant responded to the Sponsor's notification within the specified deadline but fails to claim the Prize at one of the Sponsor's regional offices within 30 days, the prize will be forfeited. Prizes consisting of tickets CANNOT be mailed.

All entries received will become property of the Sponsor and may be maintained as part of the Sponsor's Promotion records. The Sponsor reserves the right to cancel or modify the Promotion if it becomes technically or otherwise corrupted. The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Promotion; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Promotion; or to be otherwise acting in an unsportsmanlike manner. The Promotion is not sponsored, endorsed, administered by, or associated with Facebook or Instagram. Entrants agree that the Sponsor (A) shall not be responsible or liable for, and is hereby released from, any and all costs, injuries, losses or damages of any kind, including, without limitation, death and bodily injury, due in whole or in part, directly or indirectly, to participation in the Promotion and/or any Promotion-related activity, or from entrants' acceptance, receipt, possession, claiming and/or use or misuse of any prize, and (B) has not made any warranty, representation or guarantee express or implied, in fact or in law, with respect to any prize, including, without limitation, to such prize's quality or fitness for a particular purpose.
