

September 2026 MumFest VIP Ticket Social Media Giveaway Rules

OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) September 2026 MumFest VIP Ticket Social Media Giveaway (“Promotion”) begins on Tuesday, September 22nd, 2026, at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, September 27th, 2026, at 11:59 p.m. ET. During the Promotion Period, the Sponsor will publish one (1) “Promotion Post” to its official Instagram page (<https://instagram.com/nclottery>). The Promotion will include one (1) drawing at the conclusion of the Entry Period for a total of one (1) Promotion winner, who will receive eight (8) VIP Music Tent passes to MumFest on October 10 and October 11, 2026 in New Bern, two (2) meet-and-greet backstage passes, and two (2) NCEL Swag Bags (“Prize”). Estimated Retail Value (“ERV”) of this Prize is \$370.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the Draw Date.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures, and Meta rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Aristocrat Leisure Limited, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, Brightstar Global Solutions Corporation, Cactus Communications Inc., MDI Entertainment, LLC, Preston CPA, Swiss Bear Inc., and members of their respective households, are prohibited from participating in this Promotion.

3. HOW TO ENTER: There is a limit of one (1) eligible comment entry per social persona for the specified Promotion Entry Period during the Promotion. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

Winners will be randomly selected from the following method of entry:

INSTAGRAM: Users will enter with a comment on the official Instagram promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Instagram Promotion Post. Responses made on other Instagram posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. WINNERS & PRIZE: Odds of winning in the drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Instagram post at the end of each Entry Deadline period. One (1) winner will be randomly selected to receive a Prize. Total ERV of the Prize in this Promotion is \$370.

Winners are subject to minimum Federal and State taxes and other State withholdings, as required by law. The NCEL will issue an IRS Form W-2G to Prize winners for Prize wins valued above \$599.

Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be notified by comment reply or direct message on the corresponding social media platform. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize, and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responds to the Sponsor's notification within the specified deadline, but fails to provide their full name, phone number, and email address to the Sponsor's notification via Instagram, they may be disqualified, and the prize will be awarded to an alternate. Alternate winners must meet all eligibility and prize claiming requirements.

The Prize will be picked up on-site at the MumFest 2026 event, and Prize pickup instructions will be emailed to the winner.

5. **LIMITATIONS OF LIABILITY:** The Sponsor is not responsible for vendor error, interruption, deletion, or delay in operations, technical interruptions, including network, telephone equipment, electronic, computer, hardware, or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry. All entries received will become property of the Sponsor and may be maintained as part of the Sponsor's Promotion records. The Sponsor reserves the right to cancel or modify the Promotion if it becomes technically or otherwise corrupted. The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Promotion; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Promotion; or to be otherwise acting in an unsportsmanlike manner. The Promotion is not sponsored, endorsed, administered by, or associated with Facebook or Instagram.
