

**March 2026 NCEL 250 Rockingham VIP Experience Social Media Giveaway**

OFFICIAL RULES:

1. PROMOTION PERIOD: The North Carolina Education Lottery (“Sponsor”) March 2026 NCEL 250 Rockingham VIP Experience Social Media Giveaway (“Promotion”) begins on Wednesday, March 4<sup>th</sup>, 2025 at 12:00 a.m. Eastern Time (“ET”) and will end on Sunday, March 8<sup>th</sup>, 2025 at 11:59 p.m. ET (the “Entry Period”). The Promotion will include two (2) drawings (one to its official Facebook page (<https://facebook.com/nclottery>) and one to its official Instagram page (<https://instagram.com/nclottery>)) at the conclusion of the Entry Period of each drawing for a total of two (2) winners, who will each receive a VIP Experience for two (2) to the NCEL 250 NASCAR O'Reilly Auto Parts Series Race held on Saturday, April 4<sup>th</sup> at Rockingham Speedway in Rockingham, NC (“Prize”). Estimated Retail Value (“ERV”) of this Prize is \$827.26. ERV of all Prizes in this Promotion is \$1,654.52.

All comments on each of the Promotion Posts will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled

and winners determined and notified within one (1) week of the end of the Promotion Period.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. No person shall attempt to obtain multiple entries or be eligible to win more than one prize. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the NCEL social media policy. Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Meta rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, Cactus Communications Inc., Spurrier Group, MDI Entertainment, LLC, BrkThru Digital, Preston CPA, National Association for Stock Car Auto Racing, LLC ("NASCAR"), Track Enterprises, LLC, Rockingham Speedway, International Hot Rod Association (IHRA), and members of their respective households, are prohibited from participating in this Promotion.

For prizes with an ERV of \$600 or more, debt setoff will be deducted from cash awarded, if any, in accordance with NC Gen. Stat. § 18C-134. Stat. § 18C-134 within the time allotted, that winner forfeits their prize and it will be awarded to an alternate winner. In the event a winner declines the prize, the winner must submit a prize forfeiture form within 5 business days, or the winner forfeits their prize and it will be awarded to an alternate.

3. **HOW TO ENTER:** There is a limit of one (1) eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. Any social persona may enter a comment in each Promotion Entry Period but may only win one prize. All entries must be submitted within the Promotion Entry Period for the applicable drawing.

For the purposes of these Rules, a 'social persona' is one or more social media accounts across one or more social media platforms that belong to a single person.

Winners will be randomly selected from the following method of entry:

**FACEBOOK:** To enter, users will submit a comment on the official Facebook promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

INSTAGRAM: To enter, users will submit a comment on the official Instagram promotion entry post (the "Promotion Post"). A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the Entry Period on the official Instagram Promotion Post. Responses made on other Instagram posts will not be eligible.

Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. **WINNERS & PRIZE:** Odds of winning in each drawing depend on the number of entries received for the drawing. Entries will be collected via qualified comments on the Promotion's Facebook and Instagram posts at the end of the Entry Deadline period for each drawing. One (1) winner will be randomly selected from each post to receive a Prize, for a total two (2) winners in the Promotion.

The prize package is subject to mandatory taxes and other State withholdings, as required by law. Mandatory fees and state tax withholdings, in the amount of \$34.38, will be paid by the Sponsor. The Prize package value of each Prize is \$827.26, not including taxes and fees. Total ERV of all Prizes in this Promotion is \$1,654.52, not including taxes and fees. The NCEL will remit the minimum required tax withholdings to the appropriate agency and issue a W-2G form to each winner.

The NCEL is not responsible for any additional State tax and/or any applicable Federal and local taxes.

Prizes are not transferable, assignable, or redeemable for cash unless otherwise specified or required by law. Sponsor may, in its sole discretion, substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be notified by comment reply or direct message on the corresponding social media platform. If selected entrants do not respond to the notification directing them to contact the Sponsor within 72 hours of notification, they will forfeit the prize and the prize will be awarded to an alternate. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide their full name, North Carolina mailing address, birthdate, phone number and email

address to the Sponsor’s notification via Facebook or Instagram, they may be disqualified and the prize will be awarded to an alternate.

Winners and their guest must be over eighteen (18) years of age to participate in the pre-race garage walk-through. Failure of the winner or their guest to participate in the pre-race activities does not change the value of the Prize or the amount reported on the W2-G form.

Completed Claim Form can be submitted by email with a Valid State-issued ID, through the Lucke-Rewards Secure Document Upload on the NC Lottery website, or claimed at one of the Sponsor’s regional offices. The winner must submit a Winner Claim Form within ten (10) days from the first notification date by the NCEL. At least 3 attempts will be made to contact the selected entrant by email, phone call, and/or other methods of contact at the discretion of the NCEL. If winners fail to claim their prize within the ten (10) calendar day period, the NCEL will select a replacement winner from the drawing alternates.
