

## **Fast Play New Games Hit the Jackpot Promotion**

### **OFFICIAL RULES:**

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) Fast Play New Games “Hit the Jackpot” Promotion (“Promotion”) begins Monday, February 1, 2021 at 9:00 a.m. Eastern Time (“ET”) and will end Sunday, February 14, 2021 at 11:59 p.m. ET (“Promotion Period”). The Promotion will include one (1) drawing which will include five (5) Promotion Entry Periods. During the Promotion Period, Sponsor will publish five (5) posts (each a “Promotion Post”) to its official Facebook page (<https://facebook.com/nclottery>) which will announce the start of each of the five (5) Promotion Entry Periods (each a “Promotion Entry Period”). Each Promotion Entry Period will last for a total duration of forty-eight (48) hours. The Promotion Posts will be published between 9:00 a.m. ET and 7:00 p.m. ET during the Promotion Period and will include the words “Promotional Entry Period Begins Now.” Following the conclusion of the Promotion Period, Sponsor will conduct a random drawing, from amongst all eligible entries, to select ten (10) different entrants who will each receive one (1) \$100 VISA Debit Gift Cards (the “Prize”).

All comments on the Promotion Posts will be saved at the end of the entry period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the [NCEL social media policy](#). Entrants DO NOT have to be a Player’s Club or Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH

Corporation and/or IGT, Wunderman Thompson, Spurrier Group and MDI Entertainment, LLC, and members of their respective households, are prohibited from participating in this Promotion.

3. **HOW TO ENTER:** There is a limit of one eligible comment entry per social persona for each specified Promotion Entry Period during the Promotion. Any social persona may enter a comment in each Promotion Entry Period. A social persona may only win one Prize in this Promotion. All entries must be submitted within the Promotion Entry Period for the drawing. Winners will be randomly selected from the following method of entry:

FACEBOOK: Users enter by commenting on one of the Promotion Posts during the 48-hour Promotion Entry Period for that Promotion Post. A valid entry shall be defined as the first comment made by a user during the specified Promotion Entry Period on the applicable Promotion Post. Responses/comments made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook as determined by the Sponsor and adhering to the NCEL social media policy.

Facebook posts to pages other than the official Facebook page of the Sponsor, by anyone other than the Sponsor, and/or which do not include the words "Promotional Entry Period Begins Now" shall not be considered Promotion Posts, will not start a Promotion Entry Period, and comments to those posts will not be considered entries to this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. **WINNERS & PRIZE:** Odds of winning in this Promotion depend on the number of entries received for the Promotion. Entries will be collected via qualified comments on the Promotion Post at the end of the Promotion Period for each of the five (5) Promotion Posts. Ten (10) entrants will be randomly selected to win a Prize. Total Retail Value ("ERV") of each Prize is \$100. Total ERV of all Prizes awarded is \$1,000. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may substitute a prize of equal or greater value. After the drawing is conducted and verified, eligible winners will be announced in a Facebook post and notified by direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within forty-eight (48) hours of notification, they will forfeit the prize. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met.

The Prize will be mailed by certified mail to the address of the winning entrant. If an entrant responded to the Sponsor's notification within the specified deadline but fails to provide an address to receive the Prize within seven (7) days of the Sponsor's notification via Facebook, they may be disqualified and the prize will be awarded to an alternate.

The Sponsor reserves the right to cancel or modify the Promotion if it becomes technically or otherwise corrupted. The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Promotion; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Promotion; or to be otherwise acting in an unsportsmanlike manner. The Promotion is not sponsored, endorsed, administered by, or associated with Facebook.
