

## **Fast Play New Games Instant Giveaway Promotion**

### OFFICIAL RULES:

1. **ENTRY PERIOD:** The North Carolina Education Lottery (“Sponsor”) Fast Play New Games Instant Giveaway Promotion (“Promotion”) begins Monday, February 1, 2021 at 9:00 a.m. Eastern Time (“ET”) and ends Sunday, February 14, 2021 at 11:59 p.m. ET (“Giveaway Promotion Period”). During the Giveaway Promotion Period, Sponsor will publish five (5) posts (each a “Promotion Post”) to its official Facebook page (<https://facebook.com/nclottery>) which will announce the start of each of the five (5) Giveaway Entry Periods (each a “Giveaway Entry Period”). Each Giveaway Entry Period will last for a total duration of ten (10) minutes. The Promotion Posts will be published between 9:00 a.m. ET and 7:00 p.m. ET during the Giveaway Promotion Period and will include the words “Promotional Entry Period Begins Now.” Each Giveaway Entry Period will include up to one hundred (100) winners to receive one (1) Fast Play ticket coupon (the “Prize”). If fewer than 100 entries are made. The total number of entrants in the Giveaway Entry Period will receive a Prize. If more than 100 entries are made, the first 100 entries will receive a Prize. An entrant can only win one Prize during a single Giveaway Entry Period.

All comments on the Promotional Posts will be saved at the end of the entry period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Giveaway Promotion Period.

2. **ELIGIBILITY:** Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the [NCEL social media policy](#). Entrants DO NOT have to be a Player’s Club or Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by

law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, Wunderman Thompson, Spurrier Group and MDI Entertainment, LLC, and members of their respective households, are prohibited from participating in this Promotion.

3. HOW TO ENTER: There is a limit of one eligible comment entry per social persona for each specified Giveaway Entry Period during the Promotion. All qualifying entries must be submitted within the Giveaway Entry Period. Winners will be awarded a Prize based on the following method of entry and stipulations:

FACEBOOK: Users enter by commenting on the Promotion Post within ten (10) minutes of the official Facebook Promotion Post being published. A valid entry shall be defined as the first comment made by a user during the specified Giveaway Entry Period on the applicable Promotion Post. Responses/comments made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook as determined by the Sponsor and adhering to the NCEL social media policy.

Facebook posts to pages other than the official Facebook page of the Sponsor, by anyone other than the Sponsor, and/or which do not include the words "Promotional Entry Period Begins Now" shall not be considered Promotion Posts, will not start a Giveaway Entry Period, and comments to those posts will not be considered entries to this Promotion.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

4. WINNERS & PRIZE: Winning the giveaway is dependent upon being one of the first 100 commenters to comment on the official Facebook Promotion Post for the applicable Giveaway Entry Period. Entries will be collected via qualified comments on the Promotion Post at the end of the Giveaway Entry Period for each of the five (5) Promotion Posts. A maximum of one hundred (100) entrants will be selected to win a Prize for each of the Promotion Posts. The first one hundred (100) commenters will win based on the timestamp of the comment. Total Retail Value ("ERV") of each Prize is \$2. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor, in its sole discretion, may substitute a prize of equal or greater value. After the Promotion is conducted and verified, eligible winners will be announced in a Facebook post and notified by direct message via Facebook. If selected entrants do not respond to the notification directing them to contact the Sponsor within twenty-four (24) hours of notification, they will forfeit the prize and such prize will not be awarded. All Promotion entries are subject to

verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met.

The Prize will be delivered as an electronic PDF file and MUST be claimed via direct message on Facebook or via email. No other method of delivery will be provided.

All prizes must be redeemed on or prior to the expiration date stated on each prize.

The Sponsor reserves the right to cancel or modify the Promotion if it becomes technically or otherwise corrupted. The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Promotion; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Promotion; or to be otherwise acting in an unsportsmanlike manner. The Promotion is not sponsored, endorsed, administered by, or associated with Facebook.
