    post on Facebook and will include one (1) drawing to be conducted to

    entry period. The comments as entries on a promotional post will be

FACEBOOK: Users enter the first Promotional Entry Period by commenting on the promotional post. The post may instruct users to respond with a comment. A valid entry during the first Promotional Entry Period shall be defined as the first comment made by a user that contains another user's name during the specified time period for that particular official Facebook post.
