

“The Works” Promotion **Terms**

Purpose

The North Carolina Education Lottery (“NCEL”) is conducting a promotion where purchasers of The Works receive one Quick Pick ticket for the next available drawing for Powerball, Mega Millions, Lucky For Life, and Cash 5 at a discount.

Promotion Period

This promotion will run from 5:00 am Saturday, April 1, 2023 thru 2:00 am Monday May 1, 2023. These dates are subject to change at the sole discretion of the NCEL (the “Promotion Period”).

Promotion Execution

HOW TO QUALIFY:

To qualify a player must purchase The Works at any lottery retailer or online during the promotion period. This promotion is available for purchase from a lottery clerk, any Lottery Vending device, and in Online Play. The Works offers players a ticket for the upcoming drawing of Mega Millions, Powerball, Lucky For Life, and Cash 5 drawings for \$6, a \$1 discount off the regular price if purchased separately.

Players will receive four tickets; a Mega Millions Quick Pick ticket, a Powerball Quick Pick ticket, a Lucky for Life Quick Pick ticket, and a Cash 5 Quick Pick ticket for the next drawing of each game. No add on features can be added to these tickets. Tickets purchased under this promotion may not be canceled.

MUST BE 18 TO PLAY. Offer valid April 1-30, 2023. Approximate overall odds of winning Powerball are 1 in 24.87, Mega Millions are 1 in 24.00, Lucky for Life are 1 in 7.77, and Cash 5 are 1 in 10.51.
