Available at all Lottery retailers, players who buy \$5 or more of Cash 5 on a single ticket will receive a free \$1 Cash 5 Quick Pick ticket instantly good for the next available regular drawing. This promotion will run 5:00am Thursday December 29, 2022 through 2:00 am Friday December 30, 2022 (end of December 29, 2022 sales day).

Any North Carolina Education Lottery ticket purchased that qualifies for a promotion cannot be canceled during the promotion period.
