

# 7-11-21<sup>®</sup> Live Streaming Event Rules

---

1. ENTRY PERIOD:

The **North Carolina Education Lottery** (“Sponsor”) 7-11-21<sup>®</sup> Live Streaming Event Promotion (“the Live Streaming Event”) begins on Sunday, July 11, 2021 at 7:11PM Eastern Time (ET) and will end on Sunday, July 11, 2021 at 7:32PM ET (“the Drawing Entry Period”). One (1) Drawing will be conducted after the conclusion of the Drawing Entry Period to select winners from qualified entries. Twenty-five (**25**) winners will be selected to receive the cash prize, the amount of which will be determined during the Live Streaming Event. The Live Streaming Event is held via a live video broadcast on the **Facebook** platform (“the Platform”) and the winner is contacted after the Drawing, via the Platform, to confirm eligibility.

2. ELIGIBILITY: The Drawing is open to all **North Carolina** residents who are at least **eighteen (18)** years old or older. Selected entrants for prizes must be able to prove residency, North Carolina mailing address, age, their full name, phone number and email address. By submitting an entry, Entrant agrees to comply with the [NCEL social media policy](#). Entrants DO NOT have to be a Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Live Streaming Event and/or any parts thereof, including the award of any prizes, is void where prohibited by law. Employees, directors, officers, commissioners, and agents of Sponsor, Scientific Games Corporation, Pollard Banknote Limited/NeoPollard, GTECH Corporation and/or IGT, OKRP, Spurrier Group and MDI Entertainment, LLC, and members of their respective households, are prohibited from participating in this Live Streaming Event and Promotion.

3. HOW TO ENTER: All entries must be submitted within the Drawing Entry Period for the Drawing.

Winners will be randomly selected from the following method of entry:

Users are entered into the Drawing by commenting in the chat window of the Facebook Live broadcast with their favorite or ‘lucky’ number during the specified Drawing Entry Period. The comment in the chat window must contain a number in either numeric or written form, i.e., ten

or 10, to constitute a qualified entry, and deemed, by the Sponsor, as adhering to the Sponsor's social media policy. Any comment containing spam links, offensive language, personal attacks or incessant similar posting will be disqualified from this Live Streaming Event.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

Entries that do not contain a number in either numeric or written form will be disqualified.

4. **WINNER & PRIZE:** Odds of winning depend on the number of entries received for the Drawing. Entries will be collected via comments in the chat window during the Live Streaming Event for a combined pool of entrants for the drawing. Upon conclusion of the Drawing Entry Period, **25** entrants will be randomly selected to win the cash prize, the amount of which will be determined during the Live Streaming Event. During the Live Streaming Event, the Host will select the value of the cash prize amount to be awarded. Prizes are not transferable or assignable.
  
5. **WINNER NOTIFICATION:** After the drawing is conducted and verified, eligible winners will be announced and tagged in a Facebook post on the Sponsor's page. Winners must private message the Sponsor on Facebook from the winning account in order to confirm their standing as a selected winner. Winners must follow the instructions provided and submit a copy of a **North Carolina** Driver's License, **North Carolina** Identification Card, or other acceptable form of identification, bearing an address within **North Carolina**, as well as a valid email address and phone number. Individuals who fail to provide a valid email address and phone number will not be eligible to win. The following are acceptable forms of identification (bearing a **North Carolina** address):
  - A **North Carolina** Identification card or Driver's License issued by a public agency authorized to issue driver's license in **North Carolina**;
  - An Identification Card issued by any branch of the armed forces of the U.S.;
  - Identification card issued by the U.S. Bureau of Citizenship & Immigration Services

If selected entrants do not respond to the notification within **five (5) Days**, they will forfeit the prize and an alternate will be selected. All drawing entries are subject to verification by the Sponsor or its designee and may be disqualified if eligibility requirements are not met.

If an entrant responds to the Sponsor's notification within the specified deadline but fails to provide a valid email address, phone number and acceptable form of identification to the Sponsor, they may be disqualified and the prize will be awarded to an alternate. Only one prize may be won by a person in the Live Streaming Event Drawing.

For prizes of \$599 or less, the prize may be claimed by email by providing a valid email address, phone number, mailing address and acceptable form of identification.

The Sponsor reserves the right to disqualify any individual found to be tampering or attempting to tamper with the operation of the Live Streaming Event; to be acting in violation of these Official Rules; to be acting with the intent to disrupt the normal operation of this Live Streaming Event; or to be otherwise acting in an unsportsmanlike manner. The Live Streaming Event is not sponsored, endorsed, administered by, or associated with Facebook. Entrants agree that the Sponsor (A) shall not be responsible or liable for, and is hereby released from, any and all costs, injuries, losses or damages of any kind, including, without limitation, death and bodily injury, due in whole or in part, directly or indirectly, to participation in the Promotion and/or any Promotion-related activity, or from entrants' acceptance, receipt,
