Fast Play Instant Giveaway Promotion

OFFICIAL RULES:

The Promotion Posts will be published between 9:00 a.m. ET and 7:00 p.m. ET during the Giveaway Promotion Period and will include the words "Promotional Entry Period Begins Now." Each Giveaway Entry Period will include up to one hundred (100) winners to receive one (1) Fast Play ticket coupon (the "Prize"). If fewer than 100 entries are made.
