

“Get Your Hands On These Tickets” Promotion

OFFICIAL RULES:

1. PROMOTION PERIOD: The North Carolina Education Lottery (“Sponsor”) Get Your Hands On These Tickets Promotion (“Promotion”) begins on Monday, October 12, 2020 at 1:00 p.m. Eastern Time (“ET”) and will end on Saturday, October 24, 2020 at 12:59 p.m. ET (“Promotion Period”). The Promotion will include one (1) drawing on Facebook at the conclusion of the Promotion Period for a total of five (5) winners to win the prizes as set forth below. (“Prize”).

All comments on the Promotion Post (defined below) will be saved at the end of the Promotion Period and will become the exclusive property of the Sponsor. The results will be compiled and winners determined and notified within one (1) week of the end of the Promotion Period.

2. ELIGIBILITY: Promotions are open to all North Carolina residents who are at least eighteen (18) years old or older. Selected entrants for prizes must provide their full name, North Carolina mailing address, birthdate, phone number and email address. By submitting an entry, Entrant agrees to comply with the [NCEL social media policy](#). Entrants DO NOT have to be a Player’s Club or Lucke-Rewards member to win. No purchase is necessary to enter or win. Entrants are subject to all Sponsor Rules and Regulations, the North Carolina State Lottery Act, the drawing procedures and Facebook rules and regulations. This Promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law. 3. HOW TO ENTER: There is a limit of one eligible comment entry per social persona for the Promotion Period during the Promotion. All entries must be submitted within the Drawing Entry Period for the drawing.

Winners will be randomly selected from the following method of entry:

FACEBOOK: Users enter by commenting with a photo containing a screenshot of the “Get Your Hands On These” Facebook or Instagram Story video posts on the Promotion Post which will be posted on Monday, October 12, 2020 at 1:00 p.m. Eastern Time (“ET”) and will include the words “Then comment on this post with a screenshot for a chance to win” (the “Promotion Post”) A valid entry shall be defined as the first comment meeting the eligibility requirement made by a user during the specified time period on the official Facebook Promotion Post. Responses made on other Facebook posts will not be eligible.

An eligible winning entry must be deemed responsive to the instructions as posted by the Sponsor via Facebook as determined by the Sponsor and adhering to the NCEL social media policy.

Entries sent via any other method, including through any other website submission, social media, U.S. mail/courier, drop-off, etc. will be disqualified.

WINNERS & PRIZE: Odds of winning in this drawing depend on the number of entries received for that drawing. Entries will be collected via qualified comments on the Promotion’s Facebook post at the end of the Entry Deadline period for the drawing. Four (4) entrants will be randomly selected to win a Prize. Total Estimated Retail Value (“ERV”) of each Prize is \$180. Total ERV of all Prizes awarded is \$900. Prizes are not transferable, assignable or redeemable for cash unless otherwise specified or required by law. Sponsor may substitute a prize of equal or greater value. After a drawing is conducted and verified, eligible winners will be announced in a Facebook post and notified by direct message via Facebook.
