When the button is pressed a Keno 7-Spot Quick Pick ticket a \$5 Keno ticket will print for the upcoming Keno drawing and the player will be charged \$4. This is a \$1 discount off the purchase price.

This promotion is available only at locations that have a Game Touch Self Service terminal. It is not available on any other lottery selling device.
